Amendments proposed by House Committee on Education to Re-Reengrossed Senate Bill No. 313 by Senator Edmonds

1 AMENDMENT NO. 1

2 On page 1, line 4, after "R.S. 17:5029(F)," and before "and to" insert "and R.S. 39:1554(T),"

3 AMENDMENT NO. 2

4 On page 1, line 5, after "choice;" and before "to create" insert "to require the state
5 Department of Education to report to the legislature relative to educational options that
6 receive state funding; to provide for the components of the report and a submission
7 deadline;"

8 AMENDMENT NO. 3

9 On page 1, line 15, before "definitions;" insert "procurement; to provide for"

10 AMENDMENT NO. 4

11 On page 4, at the end of line 29, change "R.S. 17:4037.4." to "R.S. 17:4037.5."

12 AMENDMENT NO. 5

13 On page 5, line 23, after "§4037.4." delete the remainder of the line and delete lines 24-26
14 and insert "School choice report"

15 AMENDMENT NO. 6

16 On page 8, between lines 23 and 24, insert the following:

17 **"B. The department may enter into any contract for the**
18 **administration and management of the program or parts of the program**
19 **subject to the approval of the state board. Prior to execution of such**
20 **contract, the state board shall transmit a copy of the timeline and**
21 **process for such contract to the Senate Committee on Education, the**
22 **Senate Committee on Finance, the House Committee on Education, the**
23 **House Committee on Appropriations, and the commissioner of**
24 **administration for monitoring purposes."**

28 On page 9, at the beginning of line 5, change "C." to "D."

31 AMENDMENT NO. 10

1 On page 9, line 11, after "**allocate**" and before "**to**" insert "**funds, in an amount determined**
2 **by the state board,**"

4 On page 15, delete lines 26-29

5 AMENDMENT NO. 12

6 On page 17, between lines 27 and 28, insert the following:

7 "Section 2. R.S. 39:1554(T) is hereby enacted to read as follows:

8 §1554. Application of this Chapter

9 * * *

10 **T. This Chapter shall not apply to any contract entered into by**
11 **the state Department of Education for administration of the LA GATOR**
12 **Scholarship Program or parts of the program as provided in R.S.**
13 **17:4037.5.**

14 Section 3. The state Department of Education may enter into a contract to manage
15 the program as provided for in R.S. 17:4037.5 as enacted by this Act in accordance with the
16 provisions of LAC 28:I.1103."
