HOUSE CONCURRENT RESOLUTION NO. 140

BY REPRESENTATIVE LACOMBE

WATER/RESOURCES: Amends membership of the False River Watershed Council

1 A CONCURRENT RESOLUTION

2 To continue the False River Watershed Council, amend its membership, and provide for its
3 responsibilities.

4 WHEREAS, House Concurrent Resolution No. 123 of the 2012 Regular Session of
5 the Louisiana Legislature created the False River Watershed Council consisting of
6 representatives of state agencies, local government agencies, the legislature, and concerned
7 citizens; and

8 WHEREAS, the council was charged with meeting to ". . . deliberate and produce
9 a report that will identify, review, and evaluate management strategies to facilitate the goal
10 of improving the aquatic habitat of False River; to provide recommendations for the optimal
11 management and protection of the resources within the False River watershed, including but
12 not limited to the following: the study of impacts and potential impacts to water quality,
13 excess nutrient and sediment run-off management, shoreline modification management,
14 watershed conservation measures, and innovative habitat restoration methodology;
15 coordination of federal, state, and local efforts to improve and protect water quality; surface
16 water resource management and protection policies; recommendations for the optimal
17 management and protection of the natural resources in the False River watershed;
18 identification of various funding options for ongoing maintenance of the False River
19 watershed; recommended changes to current procedures and practices to make the
20 management and protection of the natural resources in the False River watershed more
21 efficient, comprehensive, and sustainable"; and

1 WHEREAS, the participants in the watershed council's efforts for "... improving the
2 aquatic habitat of False River; to provide recommendations for the optimal management and
3 protection of the resources within the False River watershed . . ." are united in their desire
4 to continue those efforts through continued existence of the False River Watershed Council;
5 and

6 WHEREAS, to achieve the goal of a restored False River Watershed as quickly and
7 completely as possible, it is necessary to bring together the various government interests, as
8 well as nongovernmental stakeholder organizations who possess specialized knowledge or
9 whose members represent resource users in the False River watershed; and

10 WHEREAS, the success of the council is dependent upon the participation of the
11 members, who are carefully chosen for their unique qualifications and subject matter
12 expertise; and

13 WHEREAS, the council's objectives will be best accomplished by amending its
14 membership to optimize the participation of its members.

15 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
16 continue the False River Watershed Council, whose amended membership shall be as
17 follows:

18 (1) The commissioner of the Department of Agriculture and Forestry or his
19 designee within the department.

20 (2) The secretary of the Department of Environmental Quality or his designee
21 within the department.

22 (3) The secretary of the Department of Health or his designee within the
23 department.

24 (4) The secretary of the Department of Energy and Natural Resources or his
25 designee within the department, who shall serve as vice chair of the council.

26 (5) The secretary of the Department of Wildlife and Fisheries or his designee
27 within the department.

28 (6) One member to be selected by the senator of Senate District 17.

29 (7) One member to be selected by the representative of House District 18.

30 (8) One member appointed by the Pointe Coupee Parish Council.

1 (9) The parish president of Pointe Coupee Parish or his designee, who shall serve
2 as the chairman of the council.

3 (10) The director of the Office of Homeland Security and Emergency
4 Preparedness for Pointe Coupee Parish.

5 BE IT FURTHER RESOLVED that the council shall submit an annual report to the
6 House Committee on Natural Resources and Environment and the Senate Committee on
7 Natural Resources no later than thirty days prior to the convening of each year's regular
8 session.

9 BE IT FURTHER RESOLVED that the members of the False River Watershed
10 Council shall not be entitled to receive any salary, per diem, expenses, mileage, or other
11 emollients of the office for their service on this commission, outside of any that they may
12 be entitled to by virtue of their service in another public office.

13 BE IT FURTHER RESOLVED that the council shall, at the proper time, contact the
14 following federal resource agencies to solicit their views and input with respect to
15 completing the study requested by this Resolution:

16 (1) United States Army Corps of Engineers.

17 (2) United States Fish and Wildlife Service.

18 (3) United States Geological Survey.

19 (4) National Resources Conservation Service.

20 (5) United States Department of Agriculture.

21 (6) National Oceanic and Atmospheric Administration.

22 (7) United States Environmental Protection Agency.

23 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
24 Pointe Coupee Parish Police Jury, the commissioner of the Department of Agriculture and
25 Forestry, the secretary of the Department of Environmental Quality, the secretary of the
26 Department of Health, the secretary of the Department of Energy and Natural Resources, and
27 the secretary of the Department of Wildlife and Fisheries.
