HOUSE RESOLUTION NO. 297

HEALTH/LDH: Requests the Louisiana Department of Health to promulgate rules and regulations to create an exception to facility need review procedures for certain behavioral health service providers

1	A RESOLUTION
2	To urge and request the Louisiana Department of Health to promulgate rules to create an
3	exception to facility need review procedures for behavioral health service providers
4	that offer psychosocial rehabilitation or community psychiatric support if the
5	providers meet certain requirements.
6	WHEREAS, according to the National Alliance on Mental Illness (NAMI), more
7	than forty-seven percent of adults in Louisiana report symptoms of anxiety or depression;
8	and
9	WHEREAS, according to NAMI, over one hundred eighty thousand people in
10	Louisiana have a serious mental illness; and
11	WHEREAS, according to NAMI, of the nearly two hundred thousand adults in
12	Louisiana who did not receive needed mental health care, more than forty percent did not
13	because of the cost of care; and
14	WHEREAS, according to a community needs assessment conducted by the Acadiana
15	Human Services District of the residents of Acadia, Evangeline, Iberia, Lafayette, St.
16	Landry, St. Martin, and Vermilion parishes, more than one thousand seven hundred children
17	had a substance abuse disorder, and, of that group, over one thousand five hundred children
18	did not receive treatment; and
19	WHEREAS, according to the United States Government Accountability Office, from
20	2013 through 2020, many rural hospitals and healthcare provider's offices have closed their

1 doors, thus increasing the distance between people living in rural areas and access to 2 common healthcare services; and 3 WHEREAS, in recent years, Louisiana has made efforts to decrease the barriers to 4 accessing mental health services by supporting telehealth and increasing broadband access 5 to people living in rural areas; and 6 WHEREAS, facility need review and similar policies that restrict healthcare 7 providers and professionals from expanding care into rural areas inhibit efforts to increase 8 access to health care. 9 THEREFORE, BE IT RESOLVED that the House of Representatives of the 10 Legislature of Louisiana does hereby urge and request the Louisiana Department of Health 11 (LDH) to promulgate rules to create an exception to facility need review procedures for 12 behavioral health service providers that offer psychosocial rehabilitation or community 13 psychiatric support if the providers meet all of the following requirements: 14 (1) The behavioral health service provider was licensed as a behavioral health 15 service provider by LDH on or before January 1, 2024. 16 (2) The behavioral health service provider is seeking to add psychosocial 17 rehabilitation services or community psychiatric support and treatment services to be offered 18 in the provider's licensed service area. 19 The behavioral health service provider is not operating under a provisional (3) 20 license issued by LDH. 21 (4) The behavioral health service provider is not subject to a current license 22 suspension, license revocation, or license nonrenewal action. 23 (5) The behavioral health service provider is not under a current settlement 24 agreement with LDH. 25 The behavioral health service provider has not been cited for any immediate (6) 26 jeopardy deficiencies or repeat deficiencies by LDH in the last two years. 27 The behavioral health service provider has not been issued any sanctions for (7) 28 immediate jeopardy deficiencies or repeat deficiencies by LDH in the last two years.

- 1 BE IT FURTHER RESOLVED that the Louisiana Department of Health shall
- 2 provide an update on rule promulgation in the form of a written report to the House
- 3 Committee on Health and Welfare on or before November 1, 2024.
- 4 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 5 secretary of the Louisiana Department of Health.
