14	consumption.
15	(2) "Service line" means the pipe, tubing, and fittings connecting a
16	municipal water main to a building or structure, and also includes the water
17	meter for the property.
18	Section 2. The provisions of this Act shall become effective if and when the
19	Louisiana Constitution is amended to allow the use of public funds by a political subdivision
20	for the purpose of identifying, inventorying, removing or replacing drinking water service
21	lines composed of or harmfully affected by hazardous materials including but not limited to
22	lead, copper, galvanized steel or iron.
