1 AMENDMENT NO. 1

2 In Senate Committee Amendment No. 1 proposed by the Senate Committee on Judiciary  
3 A and adopted by the Senate on May 15, 2024, designated as SCAHB358 GETTYSH 3522,  
4 on page 1, line 2, change "R.S. 13:621.21" to "R.S. 13:621.21(A)"

15 In Senate Committee Amendment No. 6 proposed by the Senate Committee on Judiciary  
16 A and adopted by the Senate on May 15, 2024, designated as SCAHB358 GETTYSH 3522,  
17 on page 1, line 17, change "Section 3." to "Section 4."

18 AMENDMENT NO. 5

19 On page 1, between lines 12 and 13, insert the following:

20 "Section 2.(A) There is hereby created an additional district judgeship for the  
21 Twenty-First Judicial District for the parishes of Livingston, St. Helena, and Tangipahoa.  
22 The additional judge herein provided for and his successors shall preside over Division L,  
23 which is hereby created for purposes of nomination and election only. The additional judge  
24 and his successors shall be elected at large and shall have jurisdiction throughout the district  
25 and shall receive the same compensation and expense allowances, payable from the same  
26 sources and in the same manner, as are now or may hereafter be provided for other judges  
27 of the district.

28 (B) The individual to be elected to the additional judgeship created by this Act for  
29 the Twenty-First Judicial District shall be elected as provided by Article V, Section 22 of  
30 the Constitution of Louisiana, and shall serve a term which shall begin on the first January  
31 first immediately following the effective date of this Act and which shall expire at the same  
32 time as is provided by law for the other judges of the court. Thereafter, the successors to the  
33 judge provided for in this Act for the Twenty-First Judicial District shall be elected at the  
34 same time and in the same manner and shall serve the same term as is now or may be  
35 provided hereafter for other judges of the court."
