2	To amend and reenact R.S. 18:18(A)(9) and 1461.7(A)(1) and to enact R.S. 18:2(16) and
3	(17), 119, and 1461.2(A)(10), relative to voter registration drives; to require
4	registration of persons conducting voter registration drives; to require
5	acknowledgment of the laws relative to voter registration; to provide for the duties
6	of the secretary of state relative thereto; to provide for definitions; to provide for a
7	criminal offense related to filling out a voter registration form; to provide relative to
8	the criminal offense of failing to timely submit a completed voter registration form
9	to a registrar of voters; and to provide for related matters.
10	Be it enacted by the Legislature of Louisiana:
11	Section 1. R.S. 18:18(A)(9) and 1461.7(A)(1) are hereby amended and reenacted and
12	R.S. 18:2(16) and (17), 119, and 1461.2(A)(10) are hereby enacted to read as follows:
13	§2. Definitions
14	As used in this Code, the following words and terms shall have the meanings
15	hereinafter ascribed to each, unless the context clearly indicates another meaning:

17	(16) "Third-party voter registration drive" means the solicitation,
18	distribution, or collection of voter registration applications by a third-party voter
19	registration organization.
20	(17) "Third-party voter registration organization" means any individual or
21	entity that solicits, distributes, or collects voter registration applications and that is
22	not required by law to do so. "Third-party voter registration organization" shall not
23	include the following:

2	immediate family in registering to vote.
3	(b) A registrar of voters or employee thereof.

8	§18. Secretary of state; powers and duties
9	A. The secretary of state shall administer the laws relating to custody of
10	voting machines and voter registration, and for this purpose he shall:
11	* * *
12	(9) Provide for the voluntary registration of individuals or entities third-party
13	voter registration organizations that conduct third-party voter registration drives in
14	the state of Louisiana.

16	§119. Voter registration drives; mandatory registration
17	A. Each third-party voter registration organization that intends to conduct a
18	voter registration drive shall first register with the secretary of state either directly
19	or through a registrar of voters in the manner prescribed by the secretary of state.
20	B. The registration required by this Section shall require acknowledgment
21	of the requirements applicable to voter registration activities as well as the election
22	offenses applicable to voter registration and voter registration activities. The
23	registration required by this Section shall not require a response from the secretary
24	of state.
25	C. This Section shall not apply to a voter registration drive conducted using
26	the electronic voter registration application provided for in R.S. 18:115.1 provided
27	that the third-party voter registration organization only provides access to the
28	electronic voter registration application and does not capture the information
29	provided for any purpose.

3	A. No person shall knowingly, willfully, or intentionally:

5	(10) Fill out information on another persons's voter registration application,
6	except when providing assistance to an applicant in the manner authorized by this
7	<u>Title.</u>

9	§1461.7. Miscellaneous election offenses; penalties
10	A. No person shall knowingly, willfully, or intentionally:
11	(1) Fail to submit to the parish registrar of voters a completed registration
12	application collected through a third-party voter registration drive within thirty days
13	of receipt of the completed application from the applicant or no later than the date
14	provided in R.S. 18:135(A)(1), whichever occurs first.
