| 7  | Be it enacted by the Legislature of Louisiana:   |
| 8  | Section 1. R.S. 37:1270(A)(8) is hereby amended and reenacted to read as follows:          |
| 9  | §1270. Duties and powers of the board  |
| 10 | A. The board shall:  |

| 12 | (8) Have the authority to establish and determine by rule minimum                          |
| 13 | requirements relative to continuing education for the renewal or reinstatement of any      |
| 14 | license or permit issued by the board, except the board shall require physicians and       |
| 15 | physician assistants practicing emergency medicine to complete an initial one-hour         |
| 16 | continuing education course on the treatment of sickle cell disease. Thereafter, a         |
| 17 | physician and physician assistant practicing emergency medicine shall complete a           |
| 18 | one-hour refresher course at regular intervals no less frequently than every three         |
