1 AN ACT 2 To amend and reenact R.S. 38:2318.1, relative to negotiations of architectural and 3 engineering professional services; to require political subdivisions and agencies to 4 negotiate for a fair and reasonable price with the most highly qualified firm selected 5 and then move to the next highly qualified selected firm if a contract cannot be 6 negotiated; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. R.S. 38:2318.1 is hereby amended and reenacted to read as follows: 9 §2318.1. Louisiana "No Bidding of Architectural and Engineering Professional 10 Services" policy 11 A. It is the policy of the state of Louisiana, its political subdivisions, and 12 agencies to select architectural and engineering professional services on the basis of 13 competence and qualifications for a fair and reasonable price. Neither the state nor 14 any of its political subdivisions or agencies may select architects, engineers, 15 landscape architects, and land surveyors wherein where price or price-related 16 information is a factor in the selection. 17 B. A political subdivision or agency shall negotiate a contract for 18 professional services at a compensation rate the agency head determines is fair and 19 reasonable with the firm selected. If the political subdivision or agency is unable to 20 negotiate a satisfactory contract with that firm, the political subdivision or agency 21 shall formally terminate negotiations and then undertake negotiations with the next selected firm, continuing the process until a contract is negotiated satisfactorily. 22

4	Department of Transportation and Development to enter into design-build contracts
5	or public-private partnership contracts, and the authority of the Louisiana
6	Transportation Authority to enter into public-private partnership contracts, R.S.
7	38:85, 2225.2.1, or 2225.2.2 relating to the authority for certain political subdivisions
8	to enter into design-build contracts, or R.S. 34:3523, relating to any port project that
9	a notice of intent is advertised for in accordance with R.S. 34:3523, prior to
10	December 31, 2020.
11	\underline{C} . \underline{D} . It is the policy of the state of Louisiana that all records, as defined in
12	R.S. $44:1(A)(2)(a)$, involved or dealing with the selection of architectural and

engineering professional services shall be open to the public in accord with the intent of Article XII, Section 3 of the Constitution of Louisiana and R.S. 44:31.
