MUNICIPAL/ORDINANCES: Provides relative to maximum penalties for violations of ordinances in St. Bernard Parish

1 AN ACT

2 To enact R.S. 33:1243(A)(3), relative to the parish of St. Bernard; to provide for parish  
3 ordinances; to provide for the violation of such ordinances; to provide for the  
4 penalties for any such violation; and to provide for related matters.

5 Notice of intention to introduce this Act has been published  
6 as provided by Article III, Section 13 of the Constitution of  
7 Louisiana.

8 Be it enacted by the Legislature of Louisiana:

9 Section 1. R.S. 33:1243(A)(3) is hereby enacted to read as follows:

10 §1243. Maximum Penalties

13 (3) Notwithstanding any other provision of law to the contrary, in the parish  
14 of St. Bernard, the maximum penalty which may be imposed for a violation of any  
15 parish ordinance as codified in the code of ordinances for the parish of St. Bernard  
16 shall be a fine of one thousand five hundred dollars and imprisonment of six months  
17 in the parish jail.

**Abstract:** Relative to parish ordinances in St. Bernard Parish, increases the maximum penalties for the violation of such ordinances.

Present law provides that the penalty that may be imposed for a violation of a parish ordinance is a \$500 fine and imprisonment of 30 days in the parish jail. Provides that the maximum penalty that may be imposed for the violation of certain ordinances in East Baton Rouge Parish is a \$1,000 fine and imprisonment of six months in the parish jail. Present law further provides that in Jefferson Parish, except for properties zoned or used for industrial activities, the maximum penalty that may be imposed for a violation of a parish ordinance is a \$1000 fine and imprisonment of six months in the parish jail. Provides further with respect to penalties for the violation of other ordinances, including those that provide for properties zoned or used for industrial activities.

Present law authorizes the imposition of a civil penalty not to exceed \$1,000 a day for each violation of certain waste treatment ordinances. Additionally authorizes the imposition of up to 100 hours of community service, in addition to, or in lieu of, penalties authorized by present law for a violation of a parish ordinance.

Proposed law retains present law and additionally provides an exception for St. Bernard Parish. Provides that the maximum penalty that may be imposed for the violation of a parish ordinance is a \$1500 fine and imprisonment of six months in the parish jail.
