SPECIAL DAY/WEEK/MONTH: Designates Thursday, May 1, 2025 as FFA Day at the state capitol and commends the state officers of the Louisiana FFA Association

A RESOLUTION

2	To designate Thursday, May 1, 2025, as FFA Day at the state capitol and to commend the
3	state officers of the Louisiana FFA Association.
4	WHEREAS, in 1917, the United States Congress passed the Smith-Hughes National
5	Vocational Education Act to appropriate federal dollars to states for the purpose of finding
6	teachers, supervisors, and directors of agricultural subjects as well as trade, home economics,
7	and industrial subjects in high schools across the United States and has since funded
8	programs created pursuant to the Act; and
9	WHEREAS, in the 1920s, student interest generated by the addition of these classes
10	prompted the first state organization of future farmers, and in 1928, thirty-three students
11	from eighteen states convened to form Future Farmers of America (FFA), known since 1988
12	as the National FFA Organization; and
13	WHEREAS, the National FFA Organization prepares and trains students for
14	leadership and professions in the science, business, and technology of agriculture in public
15	schools throughout our nation; and
16	WHEREAS, the mission of the FFA organization is to make a positive difference in
17	the lives of young people by developing their potential for premier leadership, personal
18	growth, and career success through agricultural education; and
19	WHEREAS, the motto of the FFA organization, "Learning to Do, Doing to Learn,
20	Earning to Live, Living to Serve", gives members words to live by as they experience the
21	opportunities of the organization; and

1 WHEREAS, the National FFA Organization consists of more than one million 2 members in the United States, Puerto Rico, and the Virgin Islands; and 3 WHEREAS, FFA membership in Louisiana continues to be strong and includes over 4 thirteen thousand agricultural students in two hundred fifteen chapters throughout the state; 5 and 6 WHEREAS, the members of the Louisiana House of Representatives recognize the importance of agriculture to the economy of this state, as well as the importance of the 7 8 education and training students in the state receive through agricultural education programs 9 that develop competent and assertive agricultural leadership. THEREFORE, BE IT RESOLVED that the House of Representatives of the 10 11 Legislature of Louisiana does hereby designate Thursday, May 1, 2025, as FFA Day at the 12 state capitol. 13 BE IT FURTHER RESOLVED that the House of Representatives of the Legislature 14 of Louisiana also recognizes and commends the 2024-2025 state FFA officers as follows: 15 A'arryen Fuselier, president; Breck Vincent, vice president (Area I); Emily Nevils, vice 16 president (Area II); Marianna Harris, vice president (Area III); Jonathan Hollier, vice 17 president (Area IV); Kinzie Brassell, secretary; Jasmine Jones, treasurer; Emilee Bullock, 18 reporter; McKayla Corder, sentinel; and Benjamin Robicheaux, parliamentarian. 19 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 20 executive secretary of the Louisiana Association of the National FFA Organization.
