1 A RESOLUTION

2 To express the condolences of the House of Representatives upon the death of Sean Thomas  
3 Landry.

4 WHEREAS, it is with immense sadness and profound regret that the House of  
5 Representatives of the Legislature of Louisiana has learned of the passing, on April 12,  
6 2025, of Sean Thomas Landry; and

7 WHEREAS, Sean was born on February 6, 1973, in Monroe, Louisiana, to Ronald  
8 Landry, Sr., and Marilyn Farmer Landry, and was the middle child of three siblings; he was  
9 a graduate of St. Frederick High School in Monroe and received a bachelor of arts degree  
10 from Northeast Louisiana University in 1996; and

11 WHEREAS, Sean enrolled at the Paul M. Hebert Law Center at Louisiana State  
12 University in Baton Rouge in 2001 and received a juris doctorate in 2004; he passed the  
13 Louisiana Bar Exam in 2004 and represented plaintiffs in personal injury cases with the Law  
14 Office of Kirby Kelly and the Gordon McKernan Law Firm; and

15 WHEREAS, Sean found his calling in 2020, when he opened Landry Law Firm,  
16 LLC, to defend clients facing serious criminal prosecutions; he developed a passion for jury  
17 trials and litigation and thrived when defending indigent clients; and

18 WHEREAS, outside the courtroom, Sean was always willing to enjoy a good time  
19 with friends and strangers alike; he had numerous lifelong friends who loved him and with  
20 whom he remained close, especially those from his class at St. Frederick High School; he

1 possessed a unique sense of style, regularly donning jeans, a pullover, and flip-flops when  
2 he was away from the office and at social events; and

3 WHEREAS, Sean's most notable quality was his genuine and unwavering kindness,  
4 offered to anyone he encountered; he was always the first to help, whether it be a stranger  
5 changing a tire or a friend in need of support; he engaged anyone who needed to talk and did  
6 so with kindness, empathy, and helpful suggestions; and

7 WHEREAS, Sean Thomas Landry was genuinely loved by everyone who knew him;  
8 he leaves to cherish his beautiful memory his brother, Ronald Landry, Jr.; sister, Connie  
9 Landry Nagim; nephew, Kolton Landry; and countless friends and family who deeply loved  
10 and cared for him; he will be deeply missed, but the legacy of his kindness and compassion  
11 shall live on in perpetuity in the hearts and minds of those who were privileged to have  
12 known him.

13 THEREFORE, BE IT RESOLVED that the House of Representatives of the  
14 Legislature of Louisiana does hereby express heartfelt condolences on the death of Sean  
15 Thomas Landry and does hereby extend sincerest wishes that his family, friends, and loved
