20 (b) In the case of a mutual or nonprofit corporation, the direct or indirect  
21 ownership of eighty percent or more of the surplus and the voting power of such  
22 corporation.  
23 (c) In the case of a limited liability company, the direct or indirect ownership  
24 of eighty percent or more of the membership interests in the limited liability  
25 company."

32 the expiration of any extended period, and in the absence of prior affirmative  
33 approval or disapproval, a form shall be deemed approved. The commissioner may  
34 withdraw approval at any time for cause. Approval of a form by the commissioner  
35 constitutes a waiver of any unexpired portion of the initial fifteen-day waiting  
36 period."

23 duties, and liabilities of a domestic captive insurance company in this state. The  
24 redomesticated captive insurance company possesses all rights that were obtained  
25 prior to the redomestication to the extent permitted by the laws of this state and is  
26 responsible and liable for all liabilities and obligations that were obtained prior to the  
27 redomestication. The certificate of authority, agents, appointments and licenses."
