ELECTIONS DEPARTMENT. Requests the secretary of state to review certain presidential executive orders regarding election integrity.

1	A CONCURRENT RESOLUTION
2	To urge and request the secretary of state to review certain presidential executive orders
3	regarding election integrity.
4	WHEREAS, preserving and protecting the integrity of elections and securing the
5	information and technology utilized in collecting and tabulating voting results is the
6	cornerstone of a democratically elected government; and
7	WHEREAS, on March 25, 2025, President Trump issued Executive Order 14248
8	entitled "Preserving and Protecting the Integrity of American Elections" and this order in
9	combination with a previously issued executive order on May 15, 2019 (EO 13873) sought
10	to address the potential threat of individual acquisition or use of information and
11	communications technology or services by foreign adversaries seeking to create and exploit
12	vulnerabilities in information and communications technology or services which could have
13	potentially catastrophic effects to our national security, foreign policy, and economy; and
14	WHEREAS, this presidential action seeks to institute election protections employed
15	by modern, developed nations for a free, fair, and honest election unmarred by fraud, errors,
16	or suspicion as required by federal law, including the National Voter Registration Act and
17	the Help America Vote Act as well as enforcing the citizenship requirement for federal
18	elections and improve the powers and duties of the Election Assistance Commission; and

1	WHEREAS, Secretary of State Nancy Landry should review the state's efforts to
2	ensure fair, free, and unbiased elections in our state as articulated in President Trump's
3	executive orders.
4	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
5	urge and request that Secretary of State Nancy Landry review recent changes to our Election
6	Code and other election efforts to ensure fair, free, and unbiased state elections and to
7	recommend any changes as needed.

9	Secretary of State Nancy Landry.
