Proposed bill removes the \$5 fee for a duplicate driver's license when an applicant updates a driver's license to become REAL ID compliant prior to the license becoming eligible for renewal.

EXPENDITURE EXPLANATION

Proposed bill will result in a one-time increase in SGR expenditures for the Department of Public Safety, Office of Motor Vehicles (OMV) by 33,732 in FY 26, related to updating the current OMV database and reporting system by adding a new field to track charges related to the issuance of REAL ID-compliant licenses. The Office of Technology Services (OTS) will need to develop, test, and implement the required changes to the driver's license system. OTS would perform this work at an estimated 350 hours of overtime by a Senior Application Developer (350 hours x \$95 per hour = \$33,250 x 1.45% Medicare tax = \$482; a total of \$33,732).

REVENUE EXPLANATION

Proposed measure will decrease SGR in the Department of Public Safety, Office of Motor Vehicles (OMV), by an indeterminable amount, to the extent that applicants request the issuance of a new driver's license solely for the purpose of updating the REAL ID credential on their current license. Proposed legislation eliminates the \$5 fee for a duplicate driver's license for applicants updating the REAL ID credential on their driver's license. As of 4/24/25, a total of 1,859,797 driver's licenses were noncompliant with REAL ID standards. If all 1,859,797 individuals were to update their driver's licenses to be REAL ID-compliant under the proposed bill, the maximum impact would be a \$9.3 M decrease in SGR (1,859,797 driver's licenses x \$5 fee = \$9.3 M). For reference, the table below displays the incremental fee changes based on license class and residency status.

For illustrative purposes, there are currently 1,431,396 Class E personal driver's licenses that are not REAL ID compliant. If 10% of those individuals requested a new license solely to update their REAL ID credential, it would result in a \$715,698 decrease in SGR. The \$715,698 decrease in SGR for OMV is calculated as follows:
