COURTS/JUSTICE OF PEACE: Directs the La. State Law Institute to study the justice of peace courts in Louisiana

A RESOLUTION

2	To authorize and direct the Louisiana State Law Institute to conduct a study of the justice
3	of the peace and city courts in the state, including their jurisdiction, the costs and
4	savings for their operations, the need for their continued existence, and the process
5	necessary to abolish the courts.
6	WHEREAS, justice of the peace courts are statutorily authorized by R.S. 13:2586
7	and have concurrent jurisdiction with the district courts in all civil matters; and
8	WHEREAS, there are three-hundred ninety justices of the peace in Louisiana; and
9	WHEREAS, city courts are established by special legislative Act and also have
10	concurrent jurisdiction with the district courts in all civil matters; and
11	WHEREAS, city courts are located in forty-eight cities in the state; and
12	WHEREAS, justice of the peace courts have been abolished in wards where city
13	courts exist; and
14	WHEREAS, information regarding the costs and savings associated with the
15	operation of both courts is essential to a determination of whether both courts are necessary;
16	and
17	WHEREAS, the method for abolition of either or both courts would be necessary to
18	advise the legislature on potential legislation.
19	THEREFORE, BE IT RESOLVED that the House of Representatives of the
20	Legislature of Louisiana does hereby authorize and direct the Louisiana State Law Institute
21	to conduct a study of the justice of the peace and city courts in the state of Louisiana,
