Amendments proposed by House Committee on Insurance to Reengrossed Senate Bill No. 40 by Senator Wheat

1 AMENDMENT NO. 1

2 On page 1, line 2, delete "R.S. 22:1573(D) and 1662(2)(b)," and insert "R.S. 22:1573(C)
3 through (E), 1662(2)(b), 1673(A), and 1702(A),"

4 AMENDMENT NO. 2

5 On page 1, line 3, after "requirements;" insert "to increase the number of certain continuing
6 education requirements;"

7 AMENDMENT NO. 3

8 On page 1, line 6, delete "R.S. 22:1573(D) and 1662(2)(b)" and insert "R.S. 22:1573(C)
9 through (E), 1662(2)(b), 1673(A), and 1702(A)"

10 AMENDMENT NO. 4

11 On page 1, between lines 9 and 10, insert the following:

12 "C. Life insurance producers and consultants and accident and health or
13 sickness insurance producers and consultants shall complete twenty-four hours of
14 approved instruction or verifiable approved self-study prior to each renewal of
15 license, with at least three hours dedicated to the subject of ethics. A person who
16 holds a combination of life or accident and health or sickness insurance producer
17 licenses and life or accident and health or sickness consultant licenses shall complete
18 a total of twenty-four hours of approved instruction or verifiable approved self-study,
19 with at least three hours dedicated to the subject of ethics **and at least two hours**
20 **dedicated to the subject of legislative updates in insurance law.**"

21 AMENDMENT NO. 5

22 On page 1, line 12, delete "~~twenty-two~~" and insert "twenty-four"

23 AMENDMENT NO. 6

24 On page 2, line 1, delete "~~twenty-two~~" and insert "twenty-four"

25 AMENDMENT NO. 7

26 On page 2, delete lines 3 through 8 in their entirety and insert in lieu thereof the following:

27 " insurance **and at least two hours dedicated to the subject of legislative updates**
28 **in insurance law.**

29 E. For producers authorized to write life or accident and health or sickness
30 insurance and also authorized to write property, casualty, or property and casualty
31 or personal lines insurance business, and consultants authorized to consult on life or
32 accident and health or sickness insurance and also authorized to consult on property,
33 casualty, or property and casualty or personal lines insurance business, the
34 continuing education requirement for renewal of license is twenty-four hours of
35 approved instruction or verifiable approved self-study with at least three hours of
36 approved instruction or verifiable approved self-study dedicated to the subject of
37 ethics and three hours dedicated to the subject of flood insurance. Persons who hold

1 a combination of life, accident and health or sickness, property, casualty, or property
2 and casualty insurance producer licenses and life, accident and health or sickness,
3 property, casualty, or property and casualty consultant licenses shall complete a total
4 of twenty-four hours of approved instruction or verifiable approved self-study, with
5 at least three hours dedicated to the subject of ethics, ~~and at least~~ **and at least** three hours
6 dedicated to the subject of flood insurance, **and at least two hours dedicated to the**
7 **subject of legislative updates in insurance law.**"

8 AMENDMENT NO. 8

9 On page 2, after line 18, add the following:

10 "§1673. Continuing education
11 A. An individual who holds an adjuster license and who is not exempt ~~under~~
12 **pursuant to** Subsection B of this Section shall satisfactorily complete a minimum
13 of twenty-four hours of continuing education courses, including ethics, **with at least**
14 **two hours dedicated to the subject of legislative updates in insurance law,**
15 reported on a biennial basis in conjunction with the license renewal cycle.

17 §1702. Continuing education
18 A. An individual who holds a public adjuster license and who is not exempt
19 ~~under~~ **pursuant to** Subsection B of this Section shall satisfactorily complete a
20 minimum of twenty-four hours of continuing education courses, including ethics,
21 **with at least two hours dedicated to the subject of legislative updates in**
22 **insurance law,** reported on a biennial basis in conjunction with the license renewal
23 cycle.
