13	(2) On and after January 1, 2026, all filings as provided in Paragraph A of			
14	this Article and all other provisions of this Chapter filed by an attorney any person			
15	shall only be filed in person in paper form or transmitted electronically in accordance			
16	with a system established by a clerk of court or by Louisiana Clerks' Remote Access			
17	Authority. The filer shall be responsible for ensuring that private information is not			
18	included in filings. No filing shall include the first five digits of any social security			
19	number, tax identification numbers, state identification numbers, driver's license			
20	numbers, financial account numbers, full dates of birth, or any information protected			
21	from disclosure by state or federal law. The clerk of court shall adopt a system for

12	B. Beginning January 1, 2026, all filings as provided in this Article and all		
13	other provisions of this Code filed by an attorney any person shall only be filed in		
14	person in paper form or transmitted electronically in accordance with a system		
15	established by a clerk of court or by the Louisiana Clerks' Remote Access Authority.		
16	The filer shall be responsible for ensuring that private information is not included in		
17	filings. No filing shall include the first five digits of any social security number, tax		
18	identification numbers, state identification numbers, driver's license numbers,		
19	financial account numbers, full dates of birth, or any information protected from		
20	disclosure by state or federal law. The clerk of court shall adopt a system for the		
21	electronic filing and storage of any pleading, document, or exhibit other than those		
22	documents or exhibits introduced and filed at a hearing or trial. Furthermore, in a		
23	court that accepts electronic filings in accordance with this Paragraph, the official		
24	record shall be the electronic record. A pleading or document filed electronically is		
25	deemed filed on the date and time stated on the confirmation of electronic filing sent		
26	from the system, if the clerk of court accepts the electronic filing. Public access to		
27	electronically filed pleadings and documents shall be in accordance with the rules		
28	governing access to written filings.

Abstract: Provides that civil and criminal court filings shall only be filed in person in paper form or electronically with the clerk of court.

<u>Present law</u> provides that all civil and criminal filings made by an attorney shall be filed electronically with the clerk of court.

<u>Proposed law</u> retains <u>present law</u> and provides that all civil and criminal filing made by an attorney shall be filed either in person in paper form or electronically with clerk of court.
