ALCOHOLIC BEVERAGE PERMT: Provides relative to limitations on the issuance of certain alcoholic beverage permits

2 To enact R.S. 26:81.1 and 281.1, relative to limitations of the issuance of certain alcohol 3 beverage permits; to prohibit the issuance of alcoholic beverage permits in certain 4 areas; to provide for a temporary moratorium; to provide for an effective date; to 5 provide for exceptions; and to provide for related matters. Notice of intention to introduce this Act has been published 6 7 as provided by Article III, Section 13 of the Constitution of 8 Louisiana. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. Abstract: Prohibits the issuance of certain Class B and C permits for the sale of high or low alcoholic beverages within the boundaries of District 3 of the La. House of Representatives from Aug. 1, 2025, through Dec. 31, 2026.

<u>Present law</u> provides the issuance and regulation of various high and low alcoholic beverage permits.

<u>Proposed law</u> provides that beginning on Aug. 1, 2025, and ending on Dec. 31, 2026, no permits for the sale of high or low alcoholic beverages issued under <u>present law</u> shall be granted within the boundaries of District 3 of the La. House of Representatives.

REENGROSSED HB NO. 481

<u>Proposed law</u> provides that the limitation on the issuance of permits shall apply only to Class B or Class C permits for licensed premises that contain less than 5,000 square feet of public habitable floor area.

<u>Proposed law</u> provides that valid existing permits may continue and be renewed if the permit holder remains in compliance with all other provisions of law and local ordinances.

<u>Proposed law</u> provides that if any such permit holder ceases to operate as a business or if any such permit holder fails to maintain a valid permit for any reason and for any period of time, the permit holder shall not be entitled to a new or renewal permit.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Judiciary</u> to the <u>original</u> bill:

- 1. Change the prohibition of the issuance of permits <u>from</u> Dec. 31, 2030 to Dec. 31, 2026.
- 2. Provide that the limitation on the issuance of permits shall apply only to Class B or Class C permits for licensed premises that contain less than 5,000 square feet of public habitable floor area.
