HOUSE CONCURRENT RESOLUTION NO. 44

HEALTH/CANCER: Urges the Louisiana Department of Health to develop a program for early breast cancer screening

1	A CONCURRENT RESOLUTION
2	To urge and request the Louisiana Department of Health to change the recommended age
3	for breast cancer screening for beginning of mammograms to thirty years old.
4	WHEREAS, breast cancer is the most frequently diagnosed cancer and the second
5	leading cause of cancer deaths among women in Louisiana, ranking fourth in the nation for
6	female breast cancer death rate; and
7	WHEREAS, there were six hundred seventy-eight breast cancer deaths in 2024 in
8	Louisiana; and
9	WHEREAS, female breast cancer was the most common cancer and the second
10	leading cause of cancer death in Louisiana women from 2010 to 2014; and
11	WHEREAS, between 2010 and 2014, the average annual incidence rate of female
12	breast cancer in Louisiana ranked twenty-ninth in the nation and the mortality rate was the
13	second highest in the United States; and
14	WHEREAS, Louisiana averaged one hundred thirty cases of breast cancer per one
15	hundred thousand people, including all stages from 2017 to 2021; and
16	WHEREAS, the original recommended age for breast cancer screening was forty
17	years old and continuing through seventy-four years old; and
18	WHEREAS, the Louisiana Department of Health (LDH) states early screening and
19	testing are associated with improved survival outcomes; and
20	WHEREAS, early detection significantly improves survival rates, with rates close
21	to one hundred percent when breast cancer is caught early; and

1	WHEREAS, the Louisiana Department of Health has a Louisiana Breast and Cervical	
2	Health Program (LBCHP) that offers no-cost breast and cervical cancer screenings and	
3	patient navigation services to women in Louisiana; and	
4	WHEREAS, LBCHP was founded after Congress passed the Breast and Cervical	
5	Cancer Mortality Prevention Act of 1990 and was designed to provide low-income,	
6	uninsured, and underserved women access to timely breast and cervical cancer screening and	
7	diagnostic services; and	
8	WHEREAS, LBCHP is the largest program within Louisiana Cancer Prevention &	
9	Control Programs (LCP) and has helped lower Louisiana's breast cancer death rate from the	
10	highest in the United States, as well as raised the state's screening rate to the national	
11	average; and	
12	WHEREAS, the Louisiana Department of Health operates mobile cancer screening	
13	units that travel to different locations throughout Louisiana to provide screenings to women	
14	who may not have access to other facilities.	
15	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby	
16	urge and request the Louisiana Department of Health to recommend changing initial routine	
17	mammographic breast cancer screening from age forty to age thirty.	
18	BE IT FURTHER RESOLVED that the Legislature of Louisiana does hereby request	
19	the revision of breast cancer screening guidelines to recommend the initiation of routine	
20	mammographic screening beginning at age thirty, in order to promote earlier detection and	
21	improve outcomes for individuals at risk.	
22	BE IT FURTHER RESOLVED that the Legislature of Louisiana does hereby request	
23	the Louisiana Department of Health to develop a program for early breast cancer screening	
24	beginning at age thirty within the Louisiana Breast and Cervical Health Program.	
25	BE IT FURTHER RESOLVED that a copy of the Resolution be transmitted to the	
26	secretary of the Louisiana Department of Health.
