COMMENDATIONS: Commends the Baton Rouge and Greater New Orleans chapters of the National Coalition of 100 Black Women for advocating for the rights of black women and girls

1 A RESOLUTION

2 To commend the Baton Rouge and Greater New Orleans chapters of the National Coalition  
3 of 100 Black Women for advocating for the rights of black women and girls.

4 WHEREAS, the National Coalition of 100 Black Women, Inc. (NCBW), is a  
5 501(c)(3) tax-exempt organization founded in 1981; the NCBW advocates on behalf of black  
6 women and girls, promoting sisterhood, striving for maximum community impact, and  
7 preparing our youth for a bright future; and

8 WHEREAS, the NCBW began in 1970 in New York City, with a group of twenty-  
9 four black women led by Edna Beach who began meeting to assess the impact that the racial  
10 division of the 1960s had on their community; these meetings led to the formation of the  
11 Coalition of 100 Black Women, and after more than a decade of dedicated work, the  
12 National Coalition of 100 Black Women was launched on October 24, 1981, with  
13 representatives from fourteen states and the District of Columbia; and

14 WHEREAS, today, the NCBW has thousands of members throughout sixty-two  
15 chapters representing twenty-four states and the District of Columbia; the organization is  
16 mostly made up of college graduates, and its members include physicians, dentists, lawyers,  
17 judges, corporate executives, media personalities, educators, entrepreneurs, and other skilled  
18 professionals in both the public and private sectors; and

19 WHEREAS, the NCBW exists to foster the principles of equal rights and  
20 opportunities, develop the potential of the membership for effective leadership and

1 participation in civic affairs, take action on specific issues of national and international  
2 importance, and cooperate with other persons and organizations to achieve mutual goals; and

3 WHEREAS, the mission of the NCBW is to advocate on behalf of black women and  
4 girls to promote leadership development and gender equity in the areas of health, education,  
5 and economic empowerment; and

6 WHEREAS, the NCBW's health advocacy programs focus on family and childhood  
7 obesity, cancer/health disparities, and metabolic disease; the education advocacy programs  
8 encourage excellence in education and promote the pursuit of positive lifelong goals; the  
9 economic empowerment programs include comprehensive workshops and seminars that  
10 promote economic self-sufficiency; and

11 WHEREAS, the NCBW is driven by a vision to see black women and girls live in  
12 a world where socioeconomic inequity does not exist; the organization's core values are  
13 gender equality, inclusion, respect, racial and social justice, integrity and accountability,  
14 economic empowerment, and collaboration; and

15 WHEREAS, the NCBW relies on the support of individuals, volunteers, foundations,  
16 and corporations to carry out its mission of advocating on behalf of black women and girls;  
17 for over forty years, the organization has practiced transparency and fiscal responsibility,  
18 building trust in the communities its members belong to and serve.

19 THEREFORE, BE IT RESOLVED that the House of Representatives of the  
20 Legislature of Louisiana does hereby commend the Baton Rouge and Greater New Orleans  
21 chapters of the National Coalition of 100 Black Women for advocating for the rights of  
22 black women and girls and does hereby extend sincerest wishes that the organization and its  
23 members continue to prosper in their endeavors to empower their respective communities.
