HOUSE RESOLUTION NO. 202

COURTS/JUSTICE OF PEACE: Directs the Louisiana Board of Ethics and the Louisiana Legislative Auditor to provide reports on justices of the peace

A RESOLUTION

2 To authorize and direct the board of ethics to report on the campaign finance reports filed 3 by justices of the peace and to authorize and direct the legislative auditor to report 4 on the audits of the justice of the peace courts in the state. 5 WHEREAS, the Louisiana Board of Ethics is charged with the duty of ensuring that 6 all elected officials maintain ethical standards in their conduct while serving the public; and 7 WHEREAS, all elected officials are required to file campaign finance reports with 8 the board of ethics; and 9 WHEREAS, the legislative auditor is charged with the duty of auditing the financial 10 records of certain offices and political subdivisions of the state; and 11 WHEREAS, justice of the peace courts are required by R.S. 24:513(J) to provide 12 annual financial reports to the legislative auditor; and 13 WHEREAS, it is important that the elected justices of the peace comply with the 14 requirement of filing their campaign finance reports with the board of ethics, and it is 15 equally important that the justice of the peace courts file annual financial reports with the 16 legislative auditor. 17 THEREFORE, BE IT RESOLVED that the House of Representatives of the 18 Legislature of Louisiana does hereby authorize and direct the board of ethics to report on the 19 filings of all elected justices of the peace for the years 2020 through 2025 indicating those 20 elected officials who have and have not filed their campaign finance reports. The report 21 shall be provided to the Speaker of the House of Representatives no later than thirty days 22 before the start of the 2026 Regular Session of the Legislature.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Judiciary</u> to the <u>original</u> bill:

- 1. Change the statement to be reported by the board of ethics <u>from</u> the annual financial disclosure statement <u>to</u> the campaign finance report.
- 2. Change the reporting requirement to require that the report compiled by the legislative auditor and the board of ethics be submitted to the Speaker of the House of Representatives.
