Provides relative to diabetes information. (8/1/25)

Proposed legislation requires the Louisiana Department of Health (LDH) to develop and provide type 1 diabetes information materials to the Department of Education (LDOE). Further requires LDOE to provide this information to local school boards who is to annually distribute it, via a school website or through electronic distribution methods, to the parents and legal guardians of all prekindergarten, elementary, and secondary students. Additionally requires LDOE to annually report student type 1 diabetes data to LDH.

EXPENDITURE EXPLANATION

Proposed legislation is anticipated to result in a one-time increase of \$20,000 to \$25,000 in FY 26 for the Louisiana Department of Education (LDOE) to order an enhancement to its EdLink system for secure collection of the required student health data. Reporting requirements are additionally expected to result in an increase in workload and potentially an increase in expenditures for local school systems due to the additional reporting requirements. Such an increase is indeterminable and expected to vary by school system.

The Louisiana Department of Education (LDOE) does not anticipate any increase in expenditures to disseminate type 1 diabetes informational materials provided by the Louisiana Department of Health (LDH) to local school boards, if such information is made available to LDOE electronically. There is no anticipated expenditure associated with the dissemination of this information by local school boards via electronic means. LDH reports there will be no cost to the department to develop and provide the required informational materials.
