HOUSE RESOLUTION NO. 261

HIGHWAYS: Urges and requests the Department of Transportation and Development to study the feasibility of installing flashing warning signals at certain intersections along United States Highway 61

1	A RESOLUTION
2	To urge and request the Department of Transportation and Development (DOTD) to study
3	the feasibility of installing flashing warning signals at certain intersections along
4	United States Highway 61 and Martin Luther King Drive in Reserve, Louisiana.
5	WHEREAS, United States Highway 61 and Martin Luther King Jr. Drive are vital
6	corridors in Reserve, Louisiana that carry substantial volumes of vehicular and pedestrian
7	traffic; and
8	WHEREAS, recent motor vehicle crashes along these routes have resulted in serious
9	injuries and fatalities which highlight the significant traffic safety concerns; and
10	WHEREAS, reports from the Louisiana State Police document multiple severe
11	crashes, including fatal multivehicle collisions occurring at these intersections in recent
12	years; and
13	WHEREAS, traffic safety research and state initiatives demonstrate that flashing
14	warning signals, such as flashing yellow left-turn arrows, effectively reduce accident rates
15	by alerting drivers to potential hazards; and
16	WHEREAS, the DOTD continues to prioritize road safety through the modernization
17	of traffic control devices statewide; and
18	WHEREAS, the DOTD has committed approximately eleven million dollars toward
19	upgrading one thousand two hundred traffic signals statewide, including the installation of
20	flashing warning signals proven to reduce traffic collisions; and

1	WHEREAS, flashing warning signals provide dynamic, high-visibility alerts to
2	drivers, encouraging cautious driving behavior and reducing the likelihood of crashes at
3	intersections known for hazardous traffic conditions; and
4	WHEREAS, it is in the best interest of public safety that the DOTD conduct a
5	feasibility study to determine the most effective locations and types of flashing warning
6	signals to install at key intersections along United States Highway 61 and Martin Luther
7	King Jr. Drive in Reserve, Louisiana.
8	THEREFORE, BE IT RESOLVED that the House of Representatives of the
9	Legislature of Louisiana does hereby urge and request the Department of Transportation and
10	Development to study the feasibility of installing flashing warning signals at certain
11	intersections along United States Highway 61 and Martin Luther King Jr. Drive in Reserve,
12	Louisiana.
13	BE IT FURTHER RESOLVED that the Department of Transportation and
14	Development shall at a minimum include in its feasibility study the intersections of United
15	States Highway 61 at West 10th Street, United States Highway 61 at West 2nd Street, and
16	Martin Luther King Jr. Drive at East 13th Street in Reserve, Louisiana.
17	BE IT FURTHER RESOLVED that the DOTD shall submit a written report detailing
18	its findings to the House Committee on Transportation, Highways and Public Works by
19	August 1, 2026.
20	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
21	secretary of the Department of Transportation and Development.
