HOUSE CONCURRENT RESOLUTION NO. 66

MOTOR VEHICLES: Urges and requests the office of motor vehicles and the Louisiana State Police to study methods of enforcing out-of-state vehicle insurance compliance

1	A CONCURRENT RESOLUTION
2	To urge and request the office of motor vehicles and the Louisiana State Police to study
3	methods of enforcing out-of-state vehicles to comply with Louisiana insurance
4	requirements; to study vehicle incidents involving out-of-state drivers; to study the
5	impacts of impounding out-of-state vehicles that are noncompliant with Louisiana
6	insurance requirements.
7	WHEREAS, most states require drivers to carry liability auto insurance, except for
8	New Hampshire and Virginia; and
9	WHEREAS, R.S. 32:861 requires registered owners of motor vehicles to maintain
10	liability security; and
11	WHEREAS, R.S. 32:865 provides that the state of Louisiana may impose fines
12	ranging from five hundred dollars to one thousand dollars, license suspension of twelve to
13	eighteen months, vehicle impoundment, and potential revocation of vehicle registration for
14	one hundred eighty days, depending on the circumstances; and
15	WHEREAS, all states utilize the Problem Driver Pointer System, which is a
16	computerized database maintained by the National Driver Register, which is a division in
17	the National Center for Statistics and Analysis, under the National Highway Traffic Safety
18	Administration, that tracks individuals with serious traffic-related offenses or those whose
19	driving privileges have been revoked, suspended, canceled, or denied; and
20	WHEREAS, this system allows the driver's home state to be notified of out-of-state
21	traffic violations; and

1	WHEREAS, the Insurance Information Institute reported from 2017 to 2022 that the
2	percentage of uninsured motorists increased from 11.6% in 2017 to 14% in 2022; and
3	WHEREAS, states bordering Louisiana have some of the highest rates of uninsured
4	motorists in the country; and
5	WHEREAS, establishing reports of the number and type of incidents involving out-
6	of-state drivers; and
7	WHEREAS, 32 CFR 634.49(a) and (b) details the standards for impoundment; and
8	WHEREAS, in pertinent part, the regulation specifies that vehicles should not be
9	impounded unless their presence threatens public safety or convenience and if there are
10	reasonable alternatives to impoundment; and
11	WHEREAS, R.S. 32:392(B) requires that vehicles impounded for violations of state
12	law other than R.S. 32:380 through 387, which regulate size, width, height, length, weight,
13	and load of vehicles in regular operation, shall be detained until released by any court or
14	committee magistrate having jurisdiction over the defense; and
15	WHEREAS, R.S. 32:862(B)(1) provides that for proof of compliance with insurance
16	requirements, Louisiana requires that "the original, a photocopy, or an image displayed on
17	a mobile electronic device, of one of the following documents be produced as documentation
18	of insurance: an insurance card; an insurance policy; or the declarations page of the
19	insurance policy showing coverages"; and
20	WHEREAS, the enforcement of insurance requirements on out-of-state drivers
21	operating vehicles in this state, along with contemplating the impacts of impounding
22	vehicles of drivers who are not in compliance are essential to protecting the citizens of this
23	state.
24	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
25	urge and request the office of motor vehicles and the Louisiana State Police to study the
26	feasibility and potential methods of enforcing out-of-state vehicle compliance with
27	Louisiana's mandatory vehicle insurance law.
28	BE IT FURTHER RESOLVED that the office of motor vehicles and the Louisiana

29 State Police shall study the following:

- 1 (1) Laws and ordinances that establish procedures and penalties to be imposed on
- 2 out-of-state drivers without insurance in Louisiana.
- 3 (2) The feasibility of establishing a procedure for out-of-state drivers to secure
- 4 temporary insurance coverage and tagging when penalized for driving without insurance.
- 5 BE IT FURTHER RESOLVED that the office of motor vehicles and the Louisiana
- 6 State Police shall submit a joint, written report to the House and Senate Transportation,
- 7 Highways and Public Works committees prior to January 15, 2026.
- 8 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 9 secretary of the office of motor vehicles and the superintendent of the Louisiana State Police.
