SENATE CONCURRENT RESOLUTION NO. 67

BY SENATOR HODGES

CONGRESS. To memorialize Congress to investigate geoengineering in Louisiana.

1 A CONCURRENT RESOLUTION

2 To memorialize the Congress of the United States to investigate geoengineering in
3 Louisiana.

4 WHEREAS, it is a matter of public health, environmental safety, and state interest
5 that the quality of air, soil, and water in Louisiana be protected and preserved for the
6 well-being of current and future generations; and

7 WHEREAS, evidence exists that the federal government, as well as private and
8 academic entities acting on its behalf or at its request, may have conducted or may currently
9 be conducting atmospheric geoengineering experiments involving the intentional dispersion
10 of chemicals into the atmosphere; and

11 WHEREAS, geoengineering may involve the intentional manipulation of weather
12 and climate for purposes including but not limited to increasing rainfall, reducing solar
13 radiation, and removing carbon dioxide; and

14 WHEREAS, such activities may occur within the airspace over the state of
15 Louisiana, contributing to visible phenomena which have been observed by the public and
16 are distinct from ordinary contrails generated by commercial aircraft; and

17 WHEREAS, the scientific and health impacts of these geoengineering efforts,
18 particularly those resulting in visible atmospheric trails, remain poorly understood, and there

1 is growing concern among the public regarding potential risks to environmental quality and
2 human health; and

3 WHEREAS, the United States government retains exclusive sovereignty over the
4 airspace of the United States under federal law, and it is imperative that any activity
5 conducted in this airspace, and particularly activities involving chemical dispersal, be subject
6 to public scrutiny, transparency, and federal oversight; and

7 WHEREAS, the people of Louisiana have a right to be informed about any such
8 activities occurring above their communities, and the state has a duty to act in the interest
9 of public health, safety, and environmental integrity.

10 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
11 memorialize the Congress of the United States to conduct a full, transparent, and
12 independent investigation into all activities involving the intentional dispersion of chemicals
13 into the atmosphere by any means, for geoengineering purposes including but not limited
14 to solar radiation modification, carbon dioxide removal, and weather modification
15 experiments, particularly those which may have occurred without public knowledge or
16 consent and within the airspace over the state of Louisiana.

17 BE IT FURTHER RESOLVED that such investigation should seek to determine the
18 substances being dispersed, the entities responsible, the stated purposes of such activities,
19 and the potential effects of such dispersion on air, soil, and water quality, as well as on
20 human and ecological health.

21 BE IT FURTHER RESOLVED that a copy of this Resolution shall be transmitted
22 to the president of the United States, the secretary of the United States Department of Health
23 and Human Services, the clerk of the United States House of Representatives, the secretary
24 of the United States Senate, each member of the Louisiana congressional delegation, the
25 Senate president, the speaker of the House of Representatives, the governor of Louisiana,
26 and the attorney general of Louisiana.
