1 A RESOLUTION

2 To commend Victoria D. Grant on graduating from the Southern University Law Center  
3 with a juris doctor degree.

4 WHEREAS, Victoria D. Grant is a product of Bogalusa City Schools and a 2008  
5 graduate of Bogalusa High School; she attended Southeastern Louisiana University, where  
6 she earned a bachelor of science degree in family studies in 2013 and a master of science in  
7 counseling in 2017; and

8 WHEREAS, Ms. Grant is a Louisiana Professional Counselor, and her leadership  
9 extends beyond education to her active participation in civic and professional organizations  
10 such as the Mystic Krewe of Femme Fatale, Alpha Kappa Alpha Sorority, and the Order of  
11 Eastern Star; and

12 WHEREAS, Ms. Grant is an experienced legal professional who has served as a law  
13 clerk for the First Circuit Court of Appeal and the Democratic Caucus of the Louisiana  
14 House of Representatives; she served as a committee clerk for the House Committee on  
15 Labor and Industrial Relations of the Louisiana House of Representatives and as a member  
16 of the U.S. Air Force JAG Corps 2d Bomb Wing at Barksdale Air Force Base; and

17 WHEREAS, Victoria graduated with a juris doctor degree from the Southern  
18 University Law Center in May 2025; she was a leader during her time in law school,  
19 becoming the first-ever part-time student to be elected vice president of the Student Bar  
20 Association, and she served as a secretary for the Trial Advocacy Board; and

1           WHEREAS, while in law school, Victoria was inducted into The Order of Barristers,  
2   a national honorary organization whose purpose is the encouragement of oral advocacy and  
3   brief writing skills among law students by providing national recognition to a select number  
4   of graduating seniors who have excelled in moot court, mock trial, brief writing, and other  
5   advocacy-related activities while attending law school; and

6           WHEREAS, Victoria D. Grant is most deserving of the highest recognition for her  
7   incredible determination and numerous achievements.

8           THEREFORE, BE IT RESOLVED that the House of Representatives of the  
9   Legislature of Louisiana does hereby commend Victoria D. Grant on graduating from the  
10   Southern University Law Center with a juris doctor degree and does hereby extend sincerest  
11   wishes that she continue to prosper in all of her endeavors.
