LAW ENFORCEMENT: Memorialize congress to adequately fund law enforcement and emergency responders in parishes where the Kisatchie National Forest is located

A RESOLUTION

2	To memorialize the United States Congress to take such actions as are necessary to fund the
3	sheriffs' offices in the parishes where the Kisatchie National Forest is located.
4	WHEREAS, the Kisatchie National Forest spans seven parishes in Louisiana
5	including Claiborne, Grant, Natchitoches, Rapides, Vernon, Webster, and Winn parishes
6	with a total of six hundred eight thousand four hundred eighty-seven acres; and
7	WHEREAS, the Kisatchie National Forest is owned and managed by the United
8	States federal government; and
9	WHEREAS, despite the United States federal government's ownership of the
10	Kisatchie National Forest, local Louisiana parish sheriffs' offices patrol the forest and
11	respond to emergency calls; and
12	WHEREAS, the local oversight of the Kisatchie National Forest is a substantial
13	burden to the local sheriffs' offices; and
14	WHEREAS, Payments in Lieu of Taxes, referred to as "PILT", are federal payments
15	that help local governments offset losses in property taxes due to nontaxable federal land
16	within their boundaries; and
17	WHEREAS, the amount of funding available for national forests is roughly four
18	hundred thousand dollars; and
19	WHEREAS, the available funding is not sufficient for the patrol of the Kisatchie
20	National Forest which is a substantial financial burden on the local sheriffs' offices; and

WHEREAS, PILT payments would help the parishes where the Kisatchie National

- 2 Forest is located to patrol the forest and respond to emergency calls.
- THEREFORE, BE IT RESOLVED that the House of Representatives of the
- 4 Legislature of Louisiana does hereby memorialize the United States Congress to take such
- 5 actions as are necessary to fund local sheriffs' offices in order to properly and efficiently
- 6 patrol the Kisatchie National Forest.
- 7 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 8 presiding officers of the Senate and the House of Representatives of the United States
- 9 Congress and to each member of the Louisiana congressional delegation.
