Creates the Anchor Home Task Force to study the feasibility of offering tax credits to incentivize the hiring of resident Louisiana college graduates to live and work in Louisiana the first five years after graduation.

Proposed resolution creates a task force to study and make recommendations regarding the feasibility of offering tax credits to incentivize employers to hire resident Louisiana college graduates within the first five years after graduation. The task force is required to convene its first meeting by September 30, 2026, and meet thereafter as necessary. The task force is to submit proposed recommendations by April 1, 2027, for the 2027 Regular Session of the Legislature. The staff of the Senate Committee on Revenue and Fiscal Affairs shall staff the task force.

EXPENDITURE EXPLANATION

Proposed resolution may result in a negligible increase in SGF expenditures in FY 27 associated with task force meetings.

The task force consists of six legislators, four state agency heads (or their designees), and one member appointed by the Louisiana Association of Business and Industry. Members serve without compensation but are eligible for per diem costs and/or expense reimbursement from their constituent organizations for each meeting attended. The current legislative per diem rate is \$178 per day. In addition to per diem, certain members may be eligible for travel reimbursement in accordance with state travel regulations (PPM 49 - Travel Guide).

The LFO assumes any meeting costs can be absorbed within existing budgetary resources.
