Establishes a priority status for the acquisition of surplus state vehicles for youths in the extended foster care program

Proposed law gives first preference in the acquisition of surplus vehicles to persons who are eligible for and are participating in the extended foster care program.

EXPENDITURE EXPLANATION

Proposed law may result in an increase in state and local fund expenditures, to the extent that adjusting the preference order for surplus vehicles requires state agencies or political subdivisions to purchase new vehicles instead of surplus vehicles. Proposed law would give first preference in the acquisition of surplus vehicles to persons who are eligible for and are participating in the extended foster care program. To the extent that these persons take advantage of this opportunity to acquire surplus vehicles in this manner, the pool of surplus vehicles may decrease. State agencies or political subdivisions that would have purchased these surplus vehicles may be required to purchase new vehicles, which would be most costly. The exact fiscal impact is indeterminable, as it is unknown how often extended foster care participants would purchase a surplus vehicle that a state agency or political subdivision would have purchased if they had first preference.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
