Provides for a fleet vehicle registration program

Proposed law establishes a fleet vehicle registration program within the Office of Motor Vehicles (OMV). Proposed law authorizes eligible entities that operate multiple motor vehicles to register such vehicles under a unified fleet account rather than through individual registrations. Proposed law provides for the issuance of fleet registrations on an annual or biennial basis and requires participating entities to maintain proof of financial responsibility in accordance with existing state law. Proposed law authorizes OMV to adopt rules and procedures necessary to implement and administer the program, including eligibility criteria, application processes, and compliance requirements and coordinate with the Division of Administration, the Department of Revenue, and LA Public Service Commission with respect to regulated carriers, as applicable. Proposed law provides for an effective date of January 1, 2028.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The Office of Motor Vehicles anticipates implementing the required fleet registration functionality as part of its ongoing system modernization project (Drive360/CHAMP Solution). Costs associated with implementation are expected to be absorbed within the existing system modernization contract. Therefore, the Office of Motor Vehicles does not anticipate additional state expenditures attributable to the proposed law.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. Proposed law retains all existing statutory fee provisions and does not modify the calculation, rate, or distribution of current registration fees under R.S. 47:508.
