5 On page 1, line 3, after "41:1501," and before "and R.S. 56:1948.4(B)" delete "R.S.
6 49:966(B)(3)(b)," and insert "R.S. 49:214.5.4(G)(8) and 966(B)(3)(b),"

7 AMENDMENT NO. 3

8 On page 5, delete lines 7 through 9 and insert the following:

9 "Section 8.(A) R.S. 49:214.5.4(G)(8) is hereby amended and reenacted to read as
10 follows:

11 §214.5.4. Funding and resource allocation

13 G. The money in the Coastal Protection and Restoration Fund is subject to
14 appropriations by the legislature for the purposes of integrated coastal protection.
15 The money in the fund may be used only for those projects and programs which are
16 consistent with the statement of intent, R.S. 49:214.1, and the annual plan as it
17 pertains to the integrated coastal protection and may include but not be limited to the
18 following purposes:

20 (8) The administration and operation of the Coastal Protection and
21 Restoration Authority, the Coastal Protection and Restoration Authority Board, and
22 the Governor's Advisory Commission on Coastal Protection, Restoration, and
23 Conservation, ~~and the Coastal Protection and Restoration Financing Corporation.~~

25 (B) Subpart F-1 of Part II-A of Chapter 1 of Subtitle I of Title 39 of the Louisiana
26 Revised Statutes of 1950, comprised of R.S. 39:99.26 through 99.46, is hereby repealed in
27 its entirety."

8 On page 8, delete lines 25 and 26 and insert the following:

9 "Section 23.(A) R.S. 15:574.21(D) is hereby amended and reenacted to read as
10 follows:

11 §574.21. Parole risk assessment pilot program; statistical system; agency
12 cooperation; rules promulgation

14 D. Contingent upon the availability of funding, the Department of Public
15 Safety and Corrections and the Louisiana Commission on Law Enforcement and the
16 Administration of Criminal Justice shall provide the necessary resources, including
17 clerical and administrative personnel, required by the committee on parole to
18 establish, implement and evaluate the risk assessment pilot program. Specifically,
19 the Department of Public Safety and Corrections, the Louisiana Commission on Law
20 Enforcement and the Administration of Criminal Justice, ~~the Louisiana Sentencing~~
21 ~~Commission,~~ and the Louisiana Bureau of Criminal Identification and Information
22 shall provide technical assistance to the committee on parole, and shall make
23 available all facts, records, information, data and data processing assistance required
24 by the committee.

27 R.S. 15:321 through 324, is hereby repealed in its entirety."
