

1 hydraulic features of the flood control system; and

2 WHEREAS, the accumulation of sediment in the basin has contributed to reduced
3 water depths, impaired water circulation, and the formation of spoil banks and sediment
4 deposits that restrict natural hydrologic connectivity; and

5 WHEREAS, reduced water flow and increased sedimentation can degrade water
6 quality, increase stagnation, alter nutrient dynamics, and contribute to the loss of aquatic
7 habitat; and

8 WHEREAS, these changes may adversely affect fish populations and the
9 productivity of commercial fisheries, including crawfish and finfish, as well as recreational
10 fishing opportunities relied upon by residents and visitors; and

11 WHEREAS, the continued accumulation of sediment within the basin may also affect
12 flood conveyance capacity, navigation channels, and the long-term ecological sustainability
13 of the Atchafalaya Basin; and

14 WHEREAS, a comprehensive review of sediment sources, transport mechanisms,
15 and basin management strategies is necessary to develop effective solutions to reduce
16 sediment inputs and restore water flow and ecological function within the basin.

17 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
18 create a joint legislative committee to study the water quality of the Atchafalaya Basin to
19 include the causes and effects of sediment accumulation in the Atchafalaya Basin and
20 Atchafalaya Basin Floodway System, to evaluate impacts on water flow, water quality,
21 habitat, and commercial and recreational fisheries, and to recommend strategies to reduce
22 sediment entering the basin and to remove accumulated sediment to restore ecological and
23 hydrological function.

24 BE IT FURTHER RESOLVED that the joint legislative committee created herein
25 shall be composed of members of the Senate who represent Districts 17, 21, and 22 and
26 members of the House of Representatives who represent Districts 18, 46, 50, 60 and 96.

27 BE IT FURTHER RESOLVED that the president of the Senate shall name one of the
28 Senate members of the committee as the chairperson for the limited purpose of calling the
29 first meeting, and at the first meeting, the members shall elect a chairman and other officers

1 as the joint committee may deem appropriate.

2 BE IT FURTHER RESOLVED that for purposes of this study the joint legislative
3 committee shall have all powers otherwise provided by law and by the rules of the respective
4 houses, as well as all powers inherent in legislative committees and that the members thereof
5 shall receive the per diem and mileage provided for committees by the rules of the respective
6 house.

7 BE IT FURTHER RESOLVED that the joint committee shall receive staff support
8 from the committee staff of the Senate Committee on Natural Resources and the House
9 Committee on Natural Resources and Environment.

10 BE IT FURTHER RESOLVED that in conducting this study the joint committee may
11 request data, technical assistance, and recommendations from state and federal agencies,
12 academic institutions, and stakeholders involved in the management of the Atchafalaya
13 Basin and will seek input and advice from the following:

- 14 1. The Coastal Protection and Restoration Authority.
- 15 2. The Department of Conservation and Energy.
- 16 3. The Department of Wildlife and Fisheries.
- 17 4. The Department of Environmental Quality.
- 18 5. The United States Army Corps of Engineers, New Orleans District.
- 19 6. Commercial fishing interests in the Atchafalaya Basin.
- 20 7. Recreational fishing interests in the Atchafalaya Basin.
- 21 8. Hydrologist and sediment transport experts from Louisiana public universities.
- 22 9. Landowners and local governments within the Atchafalaya Basin.
- 23 10. Atchafalaya Basin Keeper.

24 BE IT FURTHER RESOLVED that a majority of the committee shall constitute a
25 quorum for the transaction of business and all official actions of the committee shall require
26 the affirmative vote of a majority of the members.

27 BE IT FURTHER RESOLVED that the joint committee shall submit a written report
28 of its findings and recommendations, including any proposed legislative or administrative
29 actions, to the legislature and to the David R. Poynter Legislative Research Library no later

1 than April 1, 2027, and may submit supplemental reports as deemed necessary.

2 BE IT FURTHER RESOLVED that the joint committee shall terminate on January
3 11, 2028.

Creates a joint legislative committee to study and make recommendations relative to the water quality of the Atchafalaya Basin, including the causes and effects of sediment accumulation and its impacts on hydrology, habitat, and fisheries.

Provides that the joint legislative committee shall be composed of specified members of the Senate and House of Representatives representing designated legislative districts and that the president of the Senate shall designate a Senate member to call the first meeting, after which the committee shall elect its officers.

Provides that the committee shall have the powers otherwise provided by law and legislative rules, that members shall receive per diem and mileage, and that staff support shall be provided by the Senate Committee on Natural Resources and the House Committee on Natural Resources and Environment.

Authorizes the committee to request data, technical assistance, and recommendations from specified state and federal agencies, academic institutions, stakeholders, and other interested parties involved in the management of the Atchafalaya Basin.

Requires the committee to submit a written report of findings and recommendations, including any proposed legislative or administrative actions, to the legislature and the David R. Poynter Legislative Research Library not later than April 1, 2027, and authorizes supplemental reports as needed.

Provides that the joint legislative committee shall terminate on January 11, 2028.
