SENATE BILL NO. 100

BY SENATOR JENKINS

AUTOMOBILE INSURANCE. Provides for proof of insurance of transportation network companies involved in an accident. (8/1/26)

1 AN ACT

2 To amend and reenact R.S. 45:201.9, relative to proof of insurance by transportation  
3 network company drivers; to provide that a transportation network company driver  
4 shall provide proof of insurance coverage in the event of an accident; to provide that  
5 a transportation network company driver shall disclose whether he was logged on to  
6 the transportation network company's digital network or on a prearranged ride at the  
7 time of an accident; to provide for penalties; and to provide for related matters.

8 Be it enacted by the Legislature of Louisiana:

9 Section 1. R.S. 45:201.9 is hereby amended and reenacted to read as follows:

10 §201.9. Proof of insurance

11 A transportation network company driver shall carry written or digital proof  
12 of coverage satisfying R.S. 45:201.6 with him at all times during his use of a vehicle  
13 in connection with a transportation network company's digital network. In the event  
14 of an accident, a transportation network company driver shall provide this insurance  
15 coverage information to the directly interested parties, automobile insurers, and  
16 investigating police officers, upon request pursuant to R.S. 32:863.1. Upon such  
17 request, a transportation network company driver shall also disclose to directly

1 interested parties, automobile insurers, and investigating police officers, whether he  
2 was logged on to the transportation network company's digital network or on a  
3 prearranged ride at the time of an accident. **Failure by a transportation network**  
4 **company driver to comply with any provision of this Section shall subject the**  
5 **transportation network driver to the provisions of R.S. 32:863.1.**

Present law requires a transportation network company driver carry proof of coverage of insurance.

Present law requires a transportation network company driver to provide insurance coverage information, in the event of an accident, to directly interested parties, automobile insurers, and investigating officer only upon request.

Proposed law provides for penalties for failure to provide the required information.

Effective August 1, 2026.

(Amends R.S. 45:201.9)

Summary of Amendments Adopted by Senate

Senate Floor Amendments to engrossed bill

1. Restores requirement that, pursuant to R.S. 32:863.1, a transportation network driver shall disclose proof of insurance through the transportation network company upon request in the event of an accident.
