Provides relative to the death of a candidate for a party primary office who is not affiliated with a major political party

Proposed law provides that if a person who qualified as a candidate for a party primary office who is not affiliated with a major political party dies after the close of the qualifying period and before the time for closing the polls on the day of the general election, the name of the deceased candidate shall not be printed on the general election ballot; provides that if the general election ballot was printed with the deceased name, any votes received by the deceased candidate shall not be counted.

Proposed law provides that when a major party candidate qualifies for the general election in a special election held to fill an unexpired term and there are no remaining candidates for the general election then the qualified candidate is declared elected by the people.
