1 AMENDMENT NO. 1

2 On page 1, line 2, after "To" and before "repeal" insert "amend and reenact R.S.  
3 17:407.30(B), R.S. 39:82(J), 100.112(F)(1), 100.118(B), 1533(A), R.S. 48:197(B)(3), and  
4 R.S. 51:2316(B)(2), to enact R.S. 39:100.112(F)(2)(e), 100.171(D), 100.252(F),  
5 100.253(D)(4), 100.255(D)(6), 100.257, and 100.258, R.S. 51:1260(J) and 2316(D), and to"

6 AMENDMENT NO. 2

7 On page 1, line 4, after "accounts;" and before "to repeal" insert the following:

8 "to provide for the dedication of certain monies to the Louisiana Early Childhood  
9 Education Fund; to provide for use of monies in the Local Revenue Fund; to provide  
10 for use of monies in the Hurricane Ida Recovery Fund; to provide for use of monies  
11 in the Louisiana Transportation Infrastructure Fund; to provide for the use of monies  
12 in the Higher Education Campus Revitalization Fund; to provide for the use of  
13 monies in the Louisiana Economic Development Initiatives Fund; to establish the  
14 Criminal Justice Technology Innovation Fund; to establish the Strategic Investments  
15 Across Louisiana Fund; to restrict payments of certain monies in the Self-Insurance  
16 Fund; to provide for the use of monies in the Regional Maintenance and  
17 Improvement Fund; to provide for approvals for the use of certain monies in the  
18 Major Events Incentive Fund; to provide for the investment and use of monies in the  
19 Site Investment and Infrastructure Improvement Fund; to authorize appropriation  
20 from the Revenue Stabilization Trust Fund; to modify threshold amounts and  
21 percentages allowable for appropriations from the Revenue Stabilization Trust  
22 Fund;"

23 AMENDMENT NO. 3

24 On page 2, delete lines 1 through 3 and insert the following:

25 "(D) Notwithstanding any provision of law to the contrary, the state treasurer is  
26 hereby authorized and directed to transfer \$892,093 from the State General Fund (Direct)  
27 into the Criminal Justice Priority Fund.

28 (E) Notwithstanding any provision of law to the contrary, the state treasurer is  
29 hereby authorized and directed to transfer \$2,400,000 from the State General Fund (Direct)  
30 into the Federal Energy Settlement Fund."

31 AMENDMENT NO. 4

32 On page 2, between lines 12 and 13 insert the following:

33 "(D) Notwithstanding any provision of law to the contrary, the state treasurer is  
34 authorized and directed to transfer to the Fees and Self-generated Revenues of the Board of  
35 Supervisors of the Louisiana Community and Technical Colleges System the proceeds of at  
36 least one hundred six thousand two hundred twenty-three dollars relating to the assignment,  
37 transfer, sale, or lease of the Frazier Campus at Baton Rouge Community College.

38 (E) Notwithstanding any provision of law to the contrary, the state treasurer is  
39 authorized and directed to transfer to the Fees and Self-generated Revenues of the Board of  
40 Supervisors of the Louisiana Community and Technical Colleges System the proceeds of at  
41 least four million dollars relating to the assignment, transfer, sale, or lease of the Central  
42 Campus at Baton Rouge Community College.

43 Section 4. R.S. 17:107.30(B) is hereby amended and reenacted to read as follows:

1 §407.30. Louisiana Early Childhood Education Fund

3 B. After satisfying the requirements of the Bond Security and Redemption  
4 Fund as provided in Article VII, Section 9(B) of the Constitution of Louisiana,  
5 except as otherwise provided by law, monies shall be deposited into the fund as  
6 follows:

7 (1) The avails of the monies provided for in R.S. 39:82(J).

8 (2) Any appropriations, public or private grants, gifts, or donations received  
9 by the state or the Department of Education for the purposes of this Section, other  
10 than federal funds for the Child Care and Development Fund Program, shall **also** be  
11 credited to the fund.

14 Section 5. R.S. 39:82(J), 100.112(F)(1), 100.118(B) and 1533(A) are hereby  
15 amended and reenacted and R.S. 39:112(F)(2)(e), 100.171(D), 100.252(F), 100.253(D)(4),  
16 100.255(D)(6), 100.257, and 100.258 are hereby enacted to read as follows:

17 §82. Remission of cash balances to the state treasurer; authorized withdrawals of state  
18 monies after the close of the fiscal year; reports

20 J. Notwithstanding the provisions of this Section, the office of behavioral  
21 health, Louisiana Department of Health, may retain any unexpended funds in  
22 accordance with the provisions of R.S. 28:26 for Fiscal Year 2025-2026, the  
23 treasurer shall deposit all cash balances of any state funds occurring from any  
24 appropriations made by legislative act or the Interim Emergency Board to the  
25 Department of Education at the end of the fiscal year into the Louisiana Early  
26 Childhood Education Fund. Provided, however, the provisions of this Subsection  
27 shall not apply to any dedicated funds that would otherwise be retained by the  
28 respective funds or state funds for which a bona fide liability exists on the last day  
29 of Fiscal Year 2025-2026.

33 F.(1) Except as provided in Paragraphs (2) and (3) through (4) of this  
34 Subsection, no appropriations shall be made from the Revenue Stabilization Trust  
35 Fund.

37 (e) Notwithstanding any provision of this Paragraph to the contrary, for Fiscal  
38 Year 2026-2027, the minimum fund balance shall equal one billion seven hundred  
39 million dollars and the allowable percentage shall equal thirty-three percent.

41 §100.118. Local Revenue Fund

43 B. The monies in the fund shall be used solely for distribution to ad valorem  
44 tax recipient bodies within a parish to offset losses attributable to business inventory  
45 exemptions to the ad valorem tax granted by a parish. the following:

46 (1) Distribution to ad valorem tax recipient bodies within a parish to offset  
47 losses attributable to business inventory exemptions to the ad valorem tax granted  
48 by a parish.

49 (2) Beginning July 1, 2026, an amount not to exceed five million dollars  
50 annually shall be used for the purposes of reimbursing political subdivisions for costs  
51 to repair infrastructure damaged by the installation of broadband infrastructure.

55 D. All eligible entities receiving money in accordance with Subsection C of  
56 this Section shall expend all payments out of the fund in full no later than June 30,  
57 2027. All monies paid out of the fund not expended by June 30, 2027 shall be  
58 returned to the state treasury by the eligible entity.

60 §100.252. Louisiana Transportation Infrastructure Fund

1 F. For Fiscal Year 2026-2027, the monies deposited in the fund shall be  
2 utilized for the following:

3 (1) The amount of one hundred twenty-five million shall be used for  
4 transportation infrastructure initiatives.

5 (2) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
6 2027, the amount of one hundred million dollars shall be used for the Highway  
7 Priority Program.

8 (3) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
9 2027, the amount of sixty-three million dollars shall be used for district maintenance  
10 funding.

11 (4) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
12 2027, the amount of thirty-five million dollars shall be used for a box culvert  
13 program administered by the Department of Transportation and Development.

14 (5) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
15 2027, the amount of thirty million dollars will be used for state highway initiatives  
16 administered by the division of administration.

18 2027, the amount of twenty-five million dollars shall be used for a box culvert  
19 program administered by the division of administration.

26 (a) The amount of fifty-six million shall be used for transportation  
27 infrastructure initiatives.

28 (b) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
29 2027, the amount of three million eight hundred thousand dollars shall be used for  
30 land acquisitions and facilities at Louisiana State University at Alexandria.

31 (c) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
32 2027, the amount of three million three hundred thousand dollars shall be used for  
33 costs associated with training initiatives at River Parishes Community College.

34 (d) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
35 2027, the amount of one million dollars shall be used for start up costs for an  
36 aerospace program at Elaine P. Nunez Community College.

42 (6) For Fiscal Year 2026-2027 monies in the fund shall be used for the  
43 following:

44 (a) The state treasurer shall deposit the first fifty million dollars of monies  
45 received into the Site Investment and Infrastructure Improvement Fund.

46 (b) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
47 2027, the amount of twenty-five million dollars shall be used for strategic  
48 investments in the healthcare industry at Louisiana State University Health Sciences  
49 Center at Shreveport.

50 (c) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
51 2027, the amount of ten million dollars shall be used for economic development  
52 investments associated with the redevelopment of the Charity Hospital and Medical  
53 Center of Louisiana at New Orleans.

54 (d) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
55 2027, the state treasurer shall deposit the amount of five million dollars into the  
56 Rapid Response Fund.

57 (e) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
58 2027, the amount of five million dollars shall be used for economic development  
59 initiatives aimed at the wood pellet industry.

60 (f) Of the remaining monies deposited into the fund in Fiscal Year 2026-  
61 2027, the amount of two million dollars shall be used for innovation initiatives  
62 throughout the state.

2 §100.257. Criminal Justice Technology Innovation Fund

3 There is hereby established in the state treasury, as a special fund, the  
4 Criminal Justice Technology Innovation Fund, hereinafter referred to as the "fund".  
5 Any money transferred, donated, or appropriated to the fund by the legislature shall  
6 be deposited into the fund after compliance with the requirements of Article VII,  
7 Section 9(B) of the Constitution of Louisiana relative to the Bond Security and  
8 Redemption Fund. All unexpended and unencumbered monies in the fund at the end  
9 of the fiscal year shall remain in the fund. The monies in the fund shall be invested  
10 by the state treasurer in the same manner as monies in the state general fund, and  
11 interest earned on the investment of monies in the fund shall be credited to the fund.  
12 Notwithstanding the provisions of Chapter 17 of Title 39 of the Louisiana Revised  
13 Statutes of 1950, monies in the fund shall be used by offices of the district attorney  
14 to leverage technology to collaborate with other entities and facilitate interagency  
15 communication regarding care and protection of youth.

16 §100.258. Strategic Investments Across Louisiana Fund

17 There is hereby established in the state treasury, as a special fund, the  
18 Strategic Investments Across Louisiana Fund, hereinafter referred to as the "fund".  
19 Any money transferred, donated, or appropriated to the fund by the legislature shall  
20 be deposited into the fund after compliance with the requirements of Article VII,  
21 Section 9(B) of the Constitution of Louisiana relative to the Bond Security and  
22 Redemption Fund. All unexpended and unencumbered monies in the fund at the end  
23 of the fiscal year shall remain in the fund. The monies in the fund shall be invested  
24 by the state treasurer in the same manner as monies in the state general fund, and  
25 interest earned on the investment of monies in the fund shall be credited to the fund.  
26 Monies in the fund shall be subject to appropriation.

28 §1533. Self-Insurance Fund

29 A.(1) There is hereby created in the Department of the Treasury a special  
30 fund to be known as the "Self-Insurance Fund". The fund shall consist of all  
31 premiums paid by state agencies under the state's risk management program as  
32 established by this Chapter, the investment income earned from such premiums, and  
33 commissions retained in accordance with the provisions of this Title. This fund shall  
34 be used only for the payment of losses incurred by state agencies under the  
35 self-insurance program, premiums for insurance obtained through commercial  
36 carriers, administrative expenses associated with the management of the state's risk,  
37 law enforcement officers and firemen's survivors benefits as provided for in R.S.  
38 40:1665(C) and 1665.2(C), law enforcement officers and firemen's disability benefits  
39 as provided for in R.S. 40:1668, the payment of extraordinary medical and dental  
40 expenses for firemen and law enforcement officers as provided for in R.S. 40:1668.1,  
41 the payment of losses incurred by the Jefferson Parish Human Services Authority in  
42 accordance with R.S. 28:831(J), the payment of losses incurred by the Capital Area  
43 Human Services District in accordance with R.S. 28:906, the payment of losses  
44 incurred by the Florida Parishes Human Services Authority in accordance with R.S.  
45 28:856, the payment of losses incurred by the Metropolitan Human Services District  
46 in accordance with R.S. 28:866, the payment of losses incurred by the Northeast  
47 Delta Human Services Authority in accordance with R.S. 28:896, the payment of  
48 losses incurred by the South Central Louisiana Human Services Authority in  
49 accordance with R.S. 28:876, and the funding of the legal services, such funds to be  
50 administered by the commissioner of administration.

51 (2) Payments for law enforcement officers and firemen survivor and  
52 disability benefits and extraordinary medical and dental expenses as provided for in  
53 R.S. 40:1665(C), 1665.2(C), ~~and 1668,~~ and 1668.1 shall be made by the office of risk  
54 management on behalf of the Law Enforcement Officers and Firemen's Survivor  
55 Benefit Review Board as a result of a specific appropriation received for that  
56 purpose. Aggregate payments made pursuant to this Paragraph shall not exceed five  
57 million dollars in any given fiscal year.

7 Hwy 45, and La. Hwy 541, all located in Jefferson Parish, including the operation  
8 and maintenance of all lighting previously operated and maintained by the

25 ~~fund at the end of the fiscal year shall remain in the fund. The state treasurer is~~  
26 hereby directed to invest the monies in the fund in a separate portfolio. All  
27 investment income earned on monies in the fund, net of investment expenditures,  
28 shall be credited to Louisiana Economic Development, and may be used as program  
29 revenue for purposes consistent with this Section.

42 Stabilization Trust Fund for the purpose of addressing emergency conditions across  
43 the state in Fiscal Year 2026-2027."
