To authorize third party vendors to conduct a license plate inquiry on motor vehicles to verify insurance liability coverage. (8/1/26)

Proposed law authorizes the use of third-party vendors to access and conduct license plate-based queries for the limited purpose of verifying motor vehicle insurance coverage. Proposed law provides for an effective date of August 1, 2026.
