Subject: Rates paid by Corrections for Housing of State Offenders		

SHERIFFS EN +\$17,311,950 GF EX See Note Page 1 of 1
 Provides relative to the per diem rate paid by the Dept. of Public Safety and Corrections for the housing of state inmates in a parish jail or institution
Current law provides that any individual subject to confinement in a state adult penal or correctional institution to be committed to the Department of Public Safety and Corrections and authorizes the agency to house these inmates at a parish jail or institution in certain circumstances; requires the Department of Public Safety and Corrections to house these inmates at a parish jail or institution in certain circumstances; requires the Department of Public Safety and Corrections to pay a daily sum to the sheriff or governing authority that runs the jail or institution for each of these state inmates; establishes the daily sum as \$26.39 for fiscal years after FY 2019-2020. Proposed law increases the daily sum rate to \$29.39 beginning FY 2027 - 2028; and is effective upon signature of the governor or lapse of time for gubernatorial action.

EXPENDITURE EXPLANATION

Proposed law will increase annual SGF expenditures in the Department of Public Safety and Corrections-Corrections Services by \$17.3 M.


The proposed law codifies the daily rate (\$29.39) at which funding is transferred from the Department of Public Safety and Corrections - Corrections Services to parish sheriffs for local housing of state adult offenders. In FY 26, the legislature provided a one-time appropriation of \$17.4 M SGF for the 15,810 inmates housed in parish jails and other local facilities to increase the daily rate at which sheriffs would be compensated for housing them from \$26.39 to \$29.39. Currently, HB 1 includes an appropriation of \$17.4 M SGF (\$3 increase x 15,810 offenders x 365 days) for the \$3 per diem rate increase to the sheriffs contemplated in the proposed law.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
