REAPPORTIONMENT/HOUSE: Provides for redistricting of the Louisiana House of Representatives

1	AN ACT
2	To amend and reenact R.S. 24:35.5(A)(11), (12), (13), (19), (20), (21), (62),
3	(72), (73), (74), (75), (77), (82), (89), (91), (93), (94), (95), (96), (97),
4	(98), (99), (100), and (101) and (B) as enacted by Act No. 3 of the
5	Second Extraordinary Session of 2001, to provide with respect to the
6	composition of House of Representative Districts 11, 12, 13, 19, 20, 21,
7	62, 72, 73, 74, 75, 77, 82, 89, 91, 93, 94, 95, 96, 97, 98, 99, 100, and
8	101, all to legislatively adopt, approve, and ratify the agreement of the
9	parties in The Louisiana House of Representatives, et al. v. John
10	Ashcroft, et al., CA No. 1:02CV00062 (United States District Court for
11	the District of Columbia) to secure a consent declaratory judgment in
12	said matter; to provide for effective dates; and to generally and
13	specifically and otherwise provide with respect thereto.
14	Be it enacted by the Legislature of Louisiana:






