HOUSE BILL NO. 62

APPROPRIATIONS/SUPPLEML: Provides for supplemental appropriations and reductions to appropriation for FY 2005-2006 from the State General Fund and other funds (Item #30)

1 AN ACT

2 To provide for supplemental appropriations and to make certain reductions in
3 appropriations from certain sources to be allocated to designated agencies and
4 purposes in specific amounts for the making of supplemental appropriations and
5 reductions for said agencies and purposes for the 2005-2006 Fiscal Year; and to
6 provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. Appropriations out of the State General Fund (Direct) and the State
9 General Fund by Statutory Dedications out of the Rural Development Fund for Fiscal Year
10 2005-2006 for 01-100 EXECUTIVE OFFICE for support of the Office of Urban Affairs and
11 Development and the Office of Rural Development which were unobligated and unexpended
12 as of November 6, 2005, shall be null, void, and of no effect on the effective date of this Act.

13 Section 2. Appropriations out of the State General Fund (Direct) for Fiscal Year
14 2005-2006 for 20-945 STATE AID TO LOCAL GOVERNMENT ENTITIES which were
15 unobligated and unexpended as of November 6, 2005, shall be null, void, and of no effect
16 on the effective date of this Act.

17 Section 3. Appropriations out of the State General Fund (Direct) for Fiscal Year
18 2005-2006 for 20-XXX FUNDS for deposit into the Rural Development Fund for the Rural
19 Development Program, which were unobligated and unexpended as of November 6, 2005,
20 shall be null, void, and of no effect on the effective date of this Act.

1 Section 4. The commissioner of administration is authorized and directed to reduce
2 FY 2005-2006 appropriations from the State General Fund (Direct) and any other means of
3 finance in order to effect a total reduction in appropriations of Two Hundred Million and
4 No/100 (\$200,000,000.00) Dollars. Such reductions shall be realized from state activities
5 and institutions which have experienced underutilization due to closure or reduced
6 operations caused by Hurricanes Katrina and Rita.

7 Section 5. This Act shall become effective upon signature by the governor or, if not
8 signed by the governor, upon expiration of the time for bills to become law without signature
9 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
10 vetoed by the governor and subsequently approved by the legislature, this Act shall become
11 effective on the day following such approval.

Abstract: Provides for supplemental appropriations and reductions in appropriations for FY 2005-2006 from the State General Fund and other funds.

Nullifies FY 2005-2006 appropriations out the State General Fund (Direct) and State General Fund by Statutory Dedications out of the Rural Development Fund for 01-100 EXECUTIVE OFFICE for support of the Office of Urban Affairs and Development and the Office of Rural Development which were unobligated and unexpended as of November 6, 2005.

Nullifies FY 2005-2006 appropriations out of the State General Fund (Direct) for 20-945 STATE AID TO LOCAL GOVERNMENT ENTITIES which were unobligated and unexpended as of November 6, 2005.

Nullifies FY 2005-2006 appropriations out of the State General Fund (Direct) for 20-XXX FUNDS for deposit into the Rural Development Fund for the Rural Development Program which were unobligated and unexpended as of November 6, 2005.

Authorizes and directs the commissioner of administration to reduce FY 2005-2006 appropriations from the State General Fund (Direct) and any other means of finance in order to effect a total reduction in appropriations of \$200,000,000. Such reductions shall be realized from state activities and institutions which have experienced underutilization due to closure or reduced operations caused by Hurricanes Katrina and Rita.

Effective upon signature of governor or lapse of time for gubernatorial action.
