EMERGENCY PREPAREDNESS. Requests the Federal Emergency Management Agency, American Red Cross, Salvation Army, and other entities to realign their districts to conform to each other in order to provide easier access by the public, and a more rapid response to national disasters.

2	To urge and request the Federal Emergency Management Agency (FEMA), American Red

4	each other in order to provide easier access by the public, and a more rapid response
5	to national disasters.
6	WHEREAS, FEMA is charged with the duties of preparing for all types of disasters,
7	including hurricanes, and managing the federal response and recovery efforts after a national
8	disaster; and
9	WHEREAS, FEMA works in coordination with other government, non-profit, and
10	private sector organizations, such as the American Red Cross and the Salvation Army, to
11	make up the national emergency management system; and
12	WHEREAS, FEMA along with the national emergency management system aid the
13	local and state governments in preparing for, responding to, and recovering from a disaster;
14	and
15	WHEREAS, FEMA's staff and personnel are divided into ten regional offices and
16	two area offices; and
17	WHEREAS, the Salvation Army's staff and personnel are divided into four territories
18	in the United States; and

1	WHEREAS, the American Red Cross is organized into chapters in every state, and
2	consists of approximately nine hundred locally supported chapters; and
3	WHEREAS, hurricanes Katrina and Rita have shown Louisiana and the entire nation

that in the wake of a national disaster the various emergency organizations must work in concert together to provide the necessary volunteers, equipment, and supplies; and

WHEREAS, in order to assist FEMA and the organizations that compose the national emergency management system, FEMA and the organizations should realign their offices, territories, and chapters so the individual offices will conform and be better situated to provide access to the public and the necessary response to disasters.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby urge and request the Federal Emergency Management Agency (FEMA), American Red Cross, the Salvation Army, and other entities to realign their districts to conform to each other in order to provide easier access by the public, and a more rapid response to national disasters.

BE IT FURTHER RESOLVED that the Legislature of Louisiana does hereby urge and request FEMA, American Red Cross, and the Salvation Army to coordinate with the other organizations of the national emergency management system in the realignment process.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the director of the Federal Emergency Management Agency, the president and chief executive officer of American Red Cross, and the national commander of the Salvation Army.
