The proposed resolution suspends R.S. 4:214.1, which requires licensed associations to conduct a mimimum number of live racing days unless the association is prevented from live racing as a result of a natural disaster, until 60 days after the adjournment of the 2005 First Extraordinary Session. The resolution specifically references the Fairgrounds Race Course and Churchill Downs Louisiana Horseracing Company, LLC.

EXPENDITURE EXPLANATION

The reduction of expenses for the Louisiana Racing Commission resulting from a decrease in the number of live racing days will total \$261,631. This results from the reduction of live racing days from 83 to 37 days in FY 06. Personal services and other expenditures will decrease by approximately 50% from the amount anticipated in FY 06. Expenditures will be reduced as follows:

NOTE: The LSRC indicates that staff from the Fair Grounds will be utilized during the 37 race days at Louisiana Downs.

REVENUE EXPLANATION

The Louisiana State Racing Commission anticipates a loss of revenue totalling \$515,818 as a result of the reduction of live racing days from 83 to 37 days. This figure is derived by subtracting projected revenues generated during the abbreviated racing schedule at Louisiana Downs in Shreveport from the revenues which were anticipated from an 83 days schedule.
