1 AN ACT

2 To enact R.S. 23:1474(J), relative to unemployment compensation; to provide with respect  
3 to the maximum amount of wages on which contribution rates are assessed; to  
4 suspend the application of reductions in weekly benefit amounts payable to  
5 claimants; to provide for the state unemployment trust fund; and to provide for  
6 related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 23:1474(J) is hereby enacted to read as follows:

9 §1474. Administrator; Revenue Estimating Conference; "wages"; weekly benefit

1                    **J. Notwithstanding any provisions in this Section to the contrary, for**  
2                    **calendar year 2006, the administrator shall apply Procedure 3 of the table in**  
3                    **Subsection I of this Section.**

4                    Section 2. This Act shall become effective on January 1, 2006.
