**SENATE COMMITTEE AMENDMENTS**

Amendments proposed by Senate Committee on Health and Welfare to Original Senate Bill No. 33 by Senator Nevers

1 AMENDMENT NO. 1

2 On page 1, line 5 after "violations;" insert the following:

3 "to provide for the act to only become effective upon the occurrence of certain  
4 events; to provide for severability;"

5 AMENDMENT NO. 2

6 On page 1, between lines 8 and 9 insert the following:

7 **"A. Except as provided in Subsection B, the provisions of this Section shall**  
8 **become effective immediately upon, and to the extent permitted, by the**  
9 **occurrence of any of the following circumstances:**

10 **(1) Any decision of the United States Supreme Court which reverses, in whole**  
11 **or in part, *Roe v. Wade*, 410 U.S. 113, 93 S.Ct. 705, 35 L.Ed. 2d 147 (1973),**  
12 **thereby, restoring to the state of Louisiana the authority to prohibit abortion.**

13 **(2) Adoption of an amendment to the United States Constitution which, in whole**  
14 **or in part, restores to the state of Louisiana the authority to prohibit abortion.**

15 **B. The provisions of this Section shall not become effective until the**  
16 **promulgation of an executive order by the President of the United States, or the**  
17 **enactment of a federal statute or appropriation rider, or the adoption of a**  
18 **federal regulation, that authorizes the state to receive federal medicaid funds,**  
19 **pursuant to 42 U.S.C. 1396, et seq., even if the state prohibits the expenditure**  
20 **of medicaid funds for abortion, except when necessary to save the life of the**  
21 **mother.**

8 On page 2, line 19, after "**Pregnant**" delete the comma "," and before "**the human female**"  
9 insert "**means**"

10 AMENDMENT NO. 12

11 On page 2, line 22, change the semi-colon ";" to a period "."

12 AMENDMENT NO. 13

13 On page 2, line 23, after "**being**" delete the comma "," and before "**an individual**" insert  
14 "**means**"

15 AMENDMENT NO. 14

16 On page 2, line 25, change the semi-colon ";" to a period "."

17 AMENDMENT NO. 15

18 On page 2, line 26, after "**Fertilization**" delete the comma "," and before "**that point**" insert  
19 "**means**"

20 AMENDMENT NO. 16

21 On page 2, delete line 28 and 29 and on page 3, delete lines 1 and 2.

22 AMENDMENT NO. 17

23 On page 3, line 2 change "**I.**" to "**J.**"

24 AMENDMENT NO. 18

25 On page 3, line 9 change "**J.**" to "**K.**"

26 AMENDMENT NO. 19

27 On page 5, after line 17 insert the following:

28 "Section 4. The provisions of this Act are severable. If any provision, item,  
29 sentence, or word of this Act, or application thereof, is held invalid, such invalidity  
30 shall not effect other provisions, items, sentences, or words of this Act which are to  
31 be given effect without the invalid provision, item, sentence, or word of the Act."
