1 AMENDMENT NO. 1

3 their entirety and insert the following in lieu thereof:

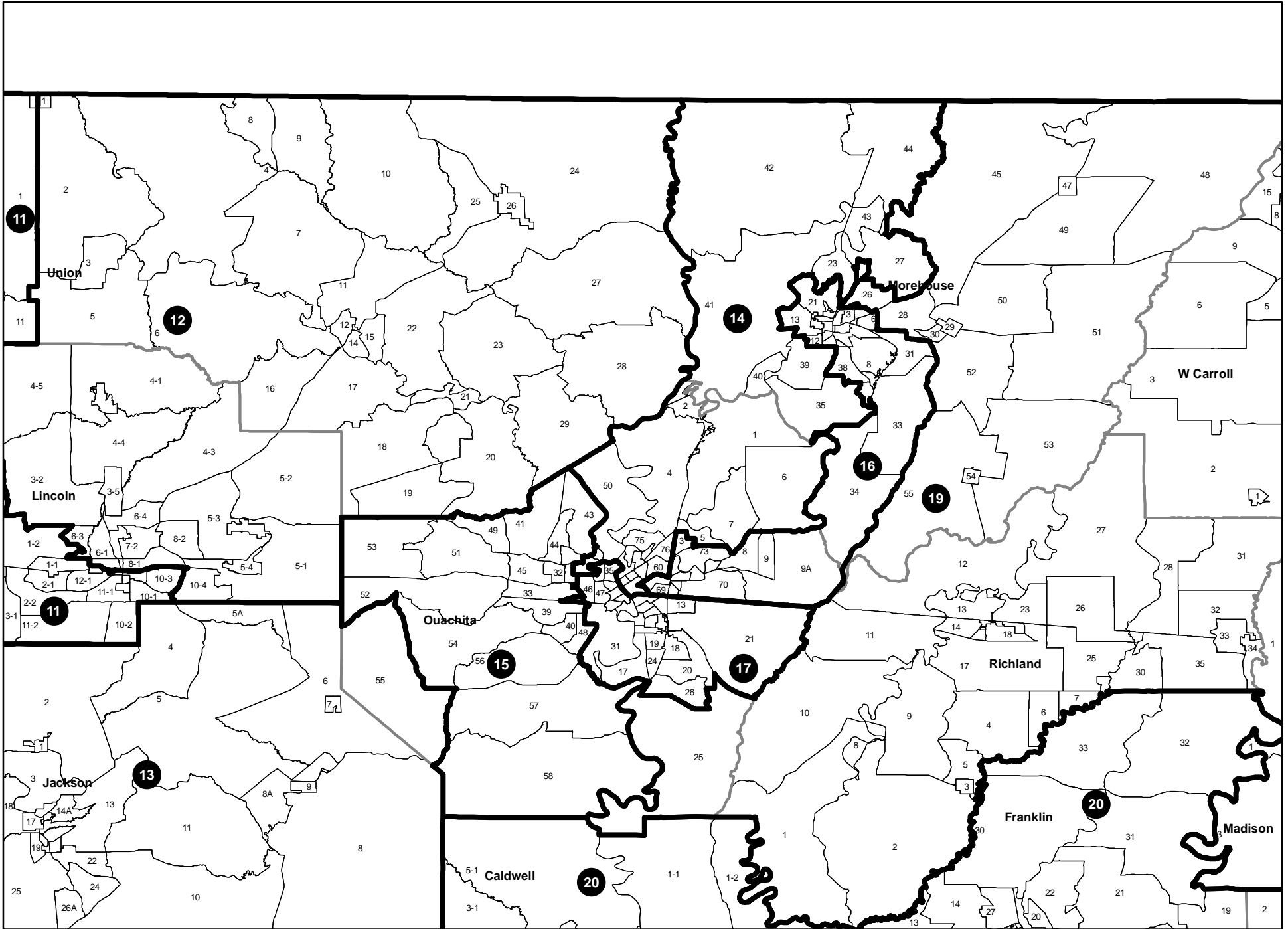

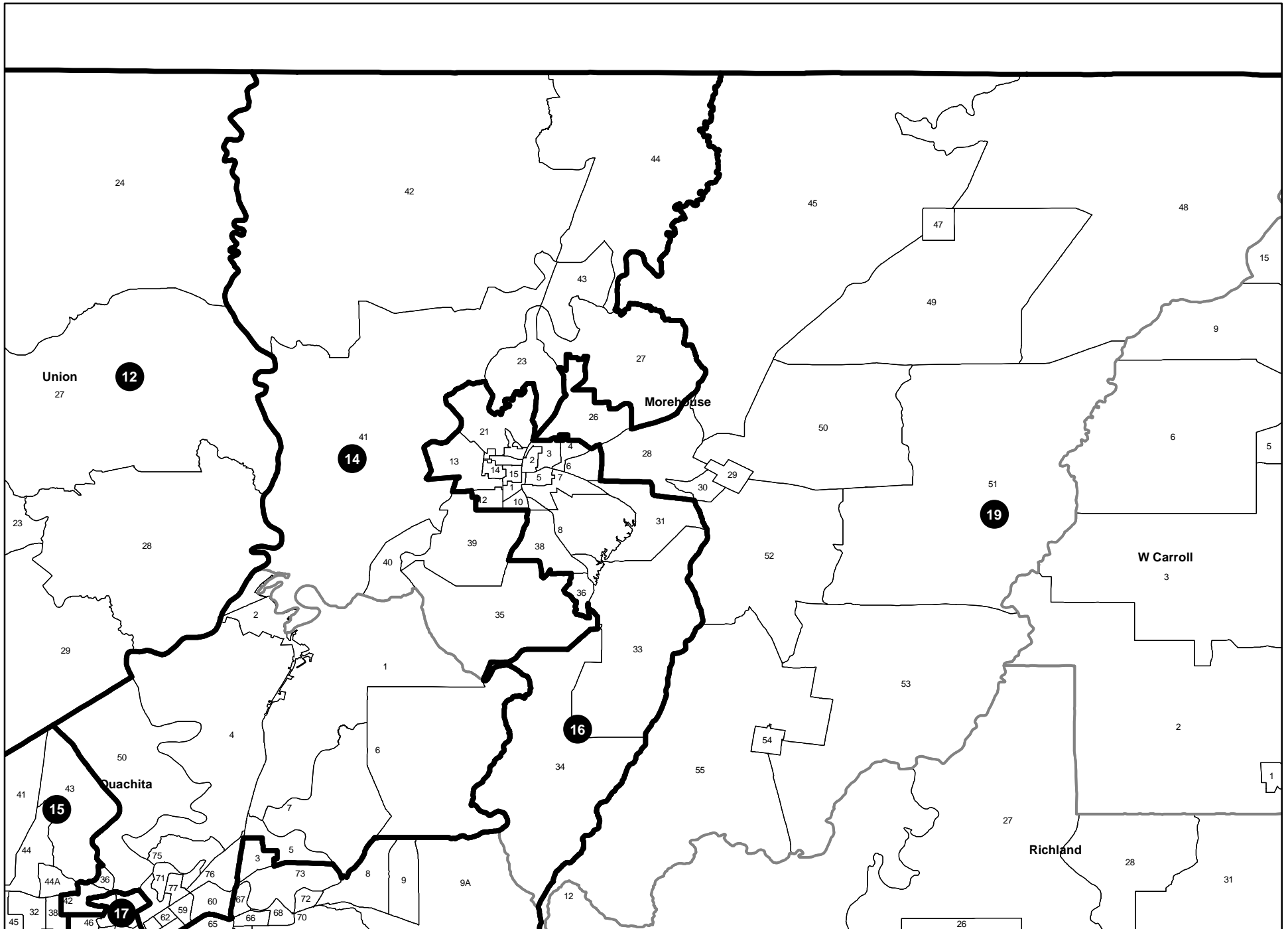
