Provides certain educational benefits for veterans who are students at La. public colleges and universities

Relative to veterans who are students at La. public colleges and universities, the bill provides for the award of educational credits for courses that are part of the student's military service and that meet certain academic standards. Requires each public postsecondary education management board to adopt certain policies (by not later than Jan. 1, 2012) as well as rules, regulations, and procedures to implement proposed law beginning with the 2012-2013 academic year and continuing thereafter. Effective upon governor's signature.
