EARLY CHILDHOOD ED. Provides for the La. Early Childhood Education Act. (gov sig)

AN ACT

2 To enact Part X-A of Chapter 1 of Title 17 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 17:407.21 through 407.25, relative to early childhood education; 3 to provide for the creation of an early childhood care and education network; to 4 5 provide for the purposes of such network and the duties and responsibilities of certain state agencies related thereto; to provide relative to early childhood education 6 7 programs and standards; to provide for an accountability system for early childhood 8 education programs; to provide relative to a quality rating system for certain day care 9 centers; to provide for legislative findings and intent; and to provide for related 10 matters. 11 Be it enacted by the Legislature of Louisiana: 12 Section 1. Part X-A of Chapter 1 of Title 17 of the Louisiana Revised Statutes of 13 1950, to be comprised of R.S. 17:407.21 through 407.25 is hereby enacted to read as follows: 14 **§407.21.** Short title 15

This Part shall be known and may be cited as the "Louisiana Early

1	§407.22. Legislative findings and intent
2	A. The legislature finds and declares that:
3	(1) In order to significantly improve outcomes at all levels of the state's
4	educational system, it is imperative that standards for, and expectations of, our
5	early childhood programs be raised to levels that will promote kindergarten
6	readiness and sustain lifelong learning and achievement.
7	(2) Publicly-funded early childhood programs should prioritize
8	kindergarten readiness and public monies should fund programs that excel at
9	achieving high levels of kindergarten readiness, or progression towards
10	kindergarten readiness, as applicable for the ages of children served.
11	(3) Parents who choose to send their children to publicly-funded early
12	childhood programs should have clear and actionable information on the quality
13	of the programs available.
14	(4) Providers of publicly-funded early childhood programs should be
15	held accountable for the public monies they receive, but given the autonomy to
16	implement an educational program that promotes and achieves kindergarten
17	readiness without undue regulation.
18	(5) State entities involved in the oversight or provision of early childhood
19	programs should collaborate, set standards of educational achievement for
20	young children that align with standards established for children enrolled in
21	grades kindergarten through twelve, and hold providers of publicly-funded
22	early childhood programs accountable without imposing undue regulation on
23	said programs.
24	(6) There are high quality early childhood programs in this state that can
25	serve as a model for increasing standards of achievement and financial

7	Section 2. This Act shall become effective upon signature by the governor or, if not
8	signed by the governor, upon expiration of the time for bills to become law without signature
9	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

<u>Proposed law</u> provides for an Early Childhood Care and Education Network and requires BESE to:

- 1. By July 1, 2013, create a comprehensive and integrated network through which to manage and oversee publicly-funded programs that provide early childhood educational services.
- 2. Establish performance targets for children under the age of three and academic standards for kindergarten readiness for three and four-year old children to be used in publicly-funded early childhood education programs.
- 3. Create a uniform assessment and accountability system for publicly-funded early childhood education programs that includes a letter grade indicative of student performance.
- 4. Coordinate with the Department of Children and Family Services (DCFS) and the Department of Health and Hospitals (DHH) to align the standards for the licensing of child care facilities, including the requirements for participation in the La. Quality Start Child Care Rating System, with the standards established for early childhood education programs.
- 5. Establish a timeline for the creation and implementation of the early childhood care and education network that shall be fully implemented by the beginning of the 2015-2016 school year.
- 6. Work cooperatively and collaboratively with DCFS and DHH, to establish a seamless early childhood educational system that is coordinated and integrated across all programs and related state agencies, regardless of public funding source.

- 7. Submit recommendations for any legislative changes needed to implement <u>proposed</u> <u>law</u> prior to the beginning of the 2013 Regular Session of the Louisiana Legislature.
- 8. Promulgate rules and regulations in accordance with the APA to implement <u>proposed</u> law.

<u>Proposed law</u> requires the Dept. of Education to submit the plans and recommendations formulated by the impacted agencies to Louisiana's Early Childhood Advisory Council, the Child Care Association of Louisiana, and the nonpublic school commission appointed by BESE for review and comment. Further requires each reviewing entity to submit its comments and recommendations to the Dept. of Education and requires the department to prepare a summary report to BESE for its consideration not later than January 1, 2013.

Provides that <u>proposed law</u> shall not apply to early childhood programs that receive public funds solely for food and nutrition assistance.

Effective upon signature of the governor or lapse of time for gubernatorial action.

## Summary of Amendments Adopted by Senate

<u>Committee Amendments Proposed by Senate Committee on Education to the original bill.</u>

- 1. Changes reference <u>from</u> "day care centers" <u>to</u> "child care facilities".
- 2. Provides that agency plans/recommendations shall be submitted for review to the Child Care Association of La. (in addition to La.'s Early Childhood Advisory Council) and moves responsibility for submission of such plans/recommendations from BESE to DOE.
- 3. Provides that <u>proposed law</u> shall not apply to early childhood programs that receive public funds solely for food and nutrition programs.

# Summary of Amendments Adopted by Senate

### Senate Floor Amendments to engrossed bill.

- 1. Makes certain technical corrections.
- 2. Requires agency plans/recommendations be submitted for review to the non-public school commission appointed by BESE (in addition to La.'s Early Childhood Advisory Council and Child Care Association of La.).
- 3. Requires each reviewing entity to submit its comments and recommendations to DOE and requires DOE to prepare a summary report to BESE.
