APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against the Department of Transportation and Development in the matter of "Melissa Martin, et al v. Joshua D. Ellis, et al" consolidated with "Stephanie Martin, et al v. Joshua D. Ellis, et al"

1 AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2013-  
3 2014 to be used to pay the consent judgment in favor of Melissa Martin, against the  
4 Department of Transportation and Development, in the suit entitled "Melissa Martin,  
5 et al v. Joshua D. Ellis, et al" consolidated with "Stephanie Martin, et al v. Joshua D.  
6 Ellis, et al"; and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. The sum of Three Thousand and No/100 (\$3,000.00) Dollars is hereby  
9 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2013-2014 to  
10 be used to pay the consent judgment in favor of Melissa Martin, against the Department of  
11 Transportation and Development, in the suit entitled "Melissa Martin, et al v. Joshua D.  
12 Ellis, et al" consolidated with "Stephanie Martin, et al v. Joshua D. Ellis, et al", bearing  
13 Number 32322, Division "E" and Number 32325, Division "C", respectively, on the docket  
14 of the Twenty-Third Judicial District Court, parish of St. James, state of Louisiana.

15 Section 2. This Act shall become effective on July 1, 2013; if vetoed by the governor  
16 and subsequently approved by the legislature, this Act shall become effective on July 1,  
17 2013, or on the day following such approval by the legislature, whichever is later.
