**Abstract:** Extends the \$1,000,000 contract limit for certain levee projects in the Terrebonne Levee and Conservation District and the South Lafourche Levee District until Dec. 31, 2016.

<u>Present law</u> requires public work exceeding the contract limit of \$150,000 to be advertised and let to the lowest responsible bidder. Provides for a contract limit of \$1,000,000 for work on certain levees for contracts awarded, or agreements entered into, until Dec. 31, 2014.

<u>Proposed law retains present law except it extends the \$1,000,000 contract limit for contracts issued by the Terrebonne Levee and Conservation District and the South Lafourche Levee District from Dec. 31, 2014 to Dec. 31, 2016.</u>

Effective upon signature of governor or lapse of time for gubernatorial action.
