1 AMENDMENT NO. 1

2 On page 1, line 2, after "1604," insert "R.S. 44:4.1(B)(5),"

3 AMENDMENT NO. 2

4 On page 1, line 4, after "1-1704," and before "and" insert "1702, and 1703"

5 AMENDMENT NO. 3

6 On page 1, line 20, after "1-1704" insert a comma "," and "1702, and 1703"

7 AMENDMENT NO. 4

8 On page 8, at the end of line 27, after "date" delete the remainder of the line

9 AMENDMENT NO. 5

10 On page 46, between lines 23 and 24, insert the following:

11 "C. A terminated corporation's name is reserved by operation of law for three
12 years after the effective date of the corporation's termination."

13 AMENDMENT NO. 6

14 On page 46, between lines 33 and 34, insert the following:

15 "(c) This Acts adds a new Subsection C to the Model Act. The new
16 Subsection automatically reserves the name of a terminated corporation for a period
17 of three years after the effective date of the corporation's termination. This
18 reservation causes the terminated corporation's name to be included among the
19 names from which a new corporate name must be distinguishable under Section 1-
20 401(B)(2), and so protects the name from adoption by another company during the
21 period in which Section 1-1444 allows the terminated corporation to be reinstated."

22 AMENDMENT NO. 7

23 On page 250, delete lines 17 through 22 in their entirety and insert:

24 "B. When the existence of the corporation terminates, the corporation's
25 juridical personality ends except for purposes of:
26 (1) Reserving the corporation's name as provided in Section 1-402(C);"

27 AMENDMENT NO. 8

28 On page 250, at the beginning of line 23, change "(a)" to "(2)"

29 AMENDMENT NO. 9

30 On page 250, at the beginning of line 25, change "(b)" to "(3)"

2 On page 253, line 29, after "corporation" delete the remainder of the line and insert a
3 semicolon ";"

16 §1702. Electronic mail addresses and short message service numbers;

18 Any electronic mail address or short message service number submitted to
19 or captured by the secretary of state pursuant to the provision of this Title shall be
20 confidential and shall not be disclosed by the secretary of state or any employee or
21 official of the Department of State.

22 §1703. Electronic notification of status changes

23 The secretary of state shall notify any person who subscribes to the secretary
24 of state's electronic mail or short message notification service and who is an officer
25 of a corporation, member or manager of a limited liability company, or partner in a
26 partnership, or any agent thereof, when a filing has occurred that may have removed
27 that person's name from documents and records of that entity held by the secretary
28 of state.

29 Section 2. R.S. 44:4.1(B)(5) is hereby amended and reenacted to read as
30 follows:

31 §4.1. Exceptions

32 * * *

33 B. The legislature further recognizes that there exist exceptions, exemptions,
34 and limitations to the laws pertaining to public records throughout the revised
35 statutes and codes of this state. Therefore, the following exceptions, exemptions, and
36 limitations are hereby continued in effect by incorporation into this Chapter by
37 citation:
