WORKERS COMPENSATION OR NO IMPACT GF EX See Note
Provides with respect to the medical treatment schedule

If a conflict exists between the Medical Director of Office of Workers' Compensation Administration within the Louisiana Workforce Commission (LWC) and any party (employer or plaintiff) to an appeal, proposed law provides that the Office of Workers' Compensation Administration may contract with alternate medical directors to render decisions. Proposed law provides that when treatment is not covered by the medical treatment schedule and the medical director deems treatment is appropriate, the employer is liable to pay.
